ICe®

OVERVIEW

ICE's Identifier Admin (IIA) is an Exchange application that will allows the creation of Short Codes for three of the new MiFID II order attributes (Execution within Firm, Investment Decision within Firm and Client).

In addition, the application supports the creation of a Profile ID which is a single identifier for all seven of the new MiFID II order attributes (three fields represented by Short Codes and the four additional values for Deal Capacity, DEA Access, Liquidity Provision Activity and Commodity Derivative Indicator). The Profile is an optional order entry method for FIX and WebICE users (individual attributes can be submitted instead).

Additionally, the application is used by IFEU Members to affirm their MiFID Investment Firm status.

The Identifier Admin supports the entry and modification of Short Code and Profile data via the GUI and through a bulk .csv upload. The bulk upload is also available via MFT.

The Identifier Admin is available as a standalone application accessible via the ICE homepage. It is automatically available to WebICE users with superuser and risk manager permissions, User Admins and can be provisioned for any other user.

It is important for users of IIA to understand the exact order and trade flow that the data supports. Under the Exchange's Rules every order is submitted by a Member of the Exchange regardless of the actual participant connectivity arrangements. The data is therefore describing the roles being performed by the Member and identifying the initial direct client of the Member. Roles such as Execution within Firm and Investment Decision refer to the Member.

Short codes are unique for each trading company. Users should take care to ensure that they are updating the relevant company which may not be the same as the main company created for the Member. Similarly, for the data to useful then the trading system addressing the Exchange needs to know which short codes and profiles have been created. I.e. if in company 100 a client short code of 5 has been created the trading system needs to quote this code on the order it submits.

1.2 ACCESS

Existing userIDs will be granted access based on the following rules:

- UserIDs with 'risk manager' or 'superuser' market type permissions or UserIDs designated as the company's ICE Administrator will have 'edit' access
 - User with 'edit' access will see a semi-hashed version of sensitive data (e.g. *****1234)
- UserIDs without the permissions noted above can also be granted 'edit' or 'view-only' access by the ICE User Admin group upon request by the company's ICE Administrator.
 - Users with 'view-only' access will see a fully-hashed version of sensitive data (e.g. ********)

1.3 SHORT CODES

The first tab within the Identifier Admin allows users to view, edit and import/export Short Codes.

1.3.1. VIEWING

1.3.1.1. COLUMNS DISPLAYED

All existing Short Codes for the company are displayed when selecting the Short Codes tab. The tab contains the following columns from left to right:

- **Short Code** User defined value for Short Code (must be an integer; 8 bytes; up to 9,223,372,036,854,775,807)
- Short Code label Optional description of the Short Code only visible within IIA
- **Type** The type of Short Code (represented by an icon)
 - Execution within Firm (the person or algorithm within the investment firm who is responsible for the execution)
 - Investment Decision within Firm (the person or algorithm within the investment firm who is responsible for the investment decision)
 - Client (the client of the member or participant of the trading venue)
- Id Type The Identifier Type
 - If Execution with Firm, the Identifier Type is a Person or Algo
 - If Investment Decision within Firm, the Identifier Type is a Person or Algo
 - If Client, the Identifier Type is a Legal Entity or Person
- Person ID Type The type of Person Identifier; applicable only to non-MIFID
 - Investment Firms (MIFID Investment Firms will see this field, but it is optional)
 - Not Specified Default value; non-MIFID Investment Firms must update this default value to one of the values described below; MIFID Investment Firms can leave the value 'Not Specified' or update
 - CONCAT A concatenation of DOB in the format YYYYMMDD, the first five characters of the first name, and the first five characters of the last name. Names shorter than five characters should be appended by # to ensure each CONCAT is always exactly 18 characters (e.g. 19720329STEPHSMITH, 19681230JAY##PATEL,19800131ROBERBELL#, etc.). All alpha characters must be in all CAPS.
 - Passport
 - National ID

Note: The UK National Insurance number is not valid for UK persons active on the ICE Endex markets. UK persons active on the ICE Endex markets should use the passport number (or CONCAT if the passport number is unavailable). UK persons with dual membership (IFEU and ICE Endex) should create a National ISD short code (and Profile) for the IFEU markets and a separate short code (and Profile) referencing the passport number (or CONCAT) for the ICE Endex markets.

- Identifier The Identifier Value required by the regulator based on the Short Code and Identifier Type
 - o If Person, the Person's Identifier
 - Up to 33 alphanumeric characters allowed. All alpha characters must be in all CAPS.
 - If Algo, the Algo's Identifier
 - Up to 50 alphanumeric characters allowed. All alpha characters must be in all CAPS.
 - o If Legal Entity, a valid Legal Entity Identifier (LEI)
- First Name, Last Name and DOB Additional data when the Client is a Person; alpha characters only in ALL CAPS, applicable only to non-MIFID Investment Firms (MIFID Investment Firms will not see these fields)
- **P(erson) Country** Required when the Execution within Firm, Investment Decision within Firm or Client are a Person. This represents the person's country and will be prepended to the Identifier for MIFID transaction reporting
- **B(ranch) Country** Additional data when the Execution within Firm or Investment Decision within Firm are a Person. For Investment Decision within Firm, this is the "country of the branch responsible for the person making the investment decision". For Execution within Firm, this is the "country of the branch supervising the person responsible for the execution"; *applicable only to non-MIFID Investment Firms (MIFID Investment Firms will not see this field)*
- **Algo Tested** Indication that the Algo has been tested and certified; required when the Execution within Firm or Investment Decision within Firm are an Algo
- Decision Maker Optional data relevant when the Short Code Type is Client"; applicable only to non-MIFID Investment Firms (MIFID Investment Firms will not see this field)

1.3.1.2. FILTERING

There is a global filter in addition to filters on each column within the Short Codes tab.

Global Filter

The global filter is a free-form text box. It is a "contains" filter that will look for any matching characters in any fields.

Short Codes can be removed from the view by selecting the Hide / Show icon. Moving Short Codes from the Visible to Hidden panel will remove them from the view. Conversely, hidden Short Codes can be made visible again.

Also, due to the sensitive nature of the 'Person Identifier', it will be hashed and encrypted immediately and required to be entered twice to ensure its accuracy. Users with "edit" capabilities will see a "semi-hashed" version of data (i.e. ****1234, only the last 4 characters will be exposed). Users with "view" capabilities will see a "fully hashed" version of the data (i.e. *********, no characters will be exposed). There is no way to ever retrieve or fully view the

original data once entered. You must re-enter the data completely if it needs to be edited or you are unsure of the contents.

If Legal Entity is specified, a valid Legal Entity Identifier (LEI) must be provided. All LEIs are exactly 20 alphanumeric characters.

1.3.4. DELETING SHORT CODES

Short Code deletion is supported via CSV upload. Delete requests are processed during the next maintenance window (6p EPT M-F). Short codes will be available for use from time of upload until the next maintenance window. Modifying the short code after uploading in the Delete file, will remove the delete request (i.e. the Short Code will still be available for use the following trading day).

The delete short code template is available in IIA in the Delete Short Codes dialogue box for download.

The template includes the following two columns:

- 1) Short Code Id=>id: numerical ID of a short code that is registered to the company selected in the top right corner of IIA.
- Short Code Type=>type: the following standard values should be used to identify the short codes types:
 - a. EXECUTION_WITHIN_FIRM,
 - b. INVESTMENT_DECISION and
 - c. CLIENT_IDENTIFICATION

Ensure the following criteria or else the upload will fail:

- 1) Short Codes are not included in a Profile (remove short code from any Profiles prior to delete request).
- 2) Short Codes are not Pending. If the Short Code is pending, then complete the set-up process prior to attempting to delete it.
- 3) Short Codes have been used on trading activity since the start of the previous trading session.
- 4) The user does not have permission to edit the Short Code.
- 5) The Short Code is reserved.

Status File:

The status file will be available in the same Delete Short Codes dialogue box. Download the Status to verify all Short Codes were processed successfully.

'Success=>success' = TRUE: Short Code will be deleted during the next maintenance window. Note: the short code will still be visible in IIA until the next maintenance window. After the short code is deleted, it can no longer be used on trading activity. 'Success=>success' = FALSE: Short Code will NOT be deleted during the next maintenance window. Review the Message for error handling.

- **Trd Capacity** Trading Capacity (indication of whether the order submission resulted from the member or participant of the trading venue carrying out matched principal trading ('MTCH'), dealing on their own account ('DEAL'), or any other trading capacity ('AOTC'); dropdown with values 'DEAL', 'MTCH' and 'AOTC'
- LP Activity Liquidity Provision Activity (indication as to whether an order is submitted to a trading venue as party of a market making strategy); 'True' or 'False'
- **CD Indicator** Commodity Derivative Indicator (indication as to whether the transaction in a commodity derivative reduces risk in an objectively measurable way in accordance with Article 57 of Directive 2014/65/EU); 'True' or 'False'. Only non-financial entities are able to enter into risk reducing transactions as defined under MiFID.
- **Exec Shortcode** User must select an existing 'Execution within Firm' Short Code.
- **Invest Shortcode** User must select an existing 'Investment Decision within Firm' Short Code when the Member is making the decision to trade.
- **Client Shortcode** User must select an existing 'Client' Short Code if Trading Capacity = MTCH or AOTC, otherwise disabled

1.4.4. DELETING PROFILES

Profile deletion is supported via CSV upload. Delete requests are processed during the next maintenance window (6p EPT M-F). Profiles will be available for use from time of upload until the next maintenance window. Modifying the Profile after uploading in the Delete file, will remove the delete request (i.e. the Profile will not be deleted and the Profile will still be available for use the following trading day).

The delete Profile template is available in IIA in the Delete Profiles dialogue box for download.

Ensure the following criteria or else the upload will fail:

- 1) Profiles are not Pending. If the Profile is pending, then complete the set-up process prior to attempting to delete it.
- 2) Profiles have NOT been used on trading activity since the start of the previous trading session.

Status File:

The status file will be available in the same Delete Profiles dialogue box. Download the Status to verify all Profiles were processed successfully.

'Success=>success' = TRUE: Profile will be deleted during the next maintenance window. Note: the Profile will still be visible in IIA until the next maintenance window. After the Profile is deleted, it can no longer be used on trading activity.

'Success=>success' = FALSE: Profile will NOT be deleted during the next maintenance window. Review the Message for error handling.

1.5 ASSIGNING USERS TO PROFILES

1.6. ICE BLOCK DEFAULT PROFILES

In ICE Block, a Broker can optionally select a Compliance Profile when entering an off-exchange trade. If the Broker does not select a Compliance Profile, the trade will be accepted, and the Member/DEA Client will have opportunity to add a Compliance Profile intraday via the WebICE Deal Book.

However, if no Compliance Profile is added by end of day, the Exchange will use the following hierarchy to assign a Compliance Profile to the off-exchange trade if the Exchange is responsible for reporting the trade:

- DEA User's ICE Block Default Compliance Profile; otherwise,
- DEA User's Company's ICE Block Default Compliance Profile; otherwise,
- Member Company's ICE Block Default Compliance Profile.
- If no Compliance Profile is found, the trade will be quarantined and not sent to the appropriate regulator until corrected.

Both the User and Company ICE Block Default Profiles are setup in IIA as described below.

1.6.1. ICE BLOCK USER PROFILE DEFAULT

The UserID ICE Block Default Profile can be added from the Users tab. Select a UserID and click the 'Assign Profiles' button.

The 'ICE Block Default' dropdown is at the top of the window and contains all Profiles. One can be optionally assigned to a userID as the ICE Block Default. It will be used by the Exchange in MIFID Transaction Reporting when a Broker does not enter a Compliance Profile on an off-exchange trade for that user.

1.8 MFT SUPPORT FOR BULK IMPORT/EXPORT

IIA also supports the ability to upload the Short Code and Profile .csv files that can already be uploaded via the application to also be uploaded via MFT.

Firms that request MFT access for IIA will have a userID that will be defaulted in their company's root data folder or a root folder with access to individual company folders in the case where the userID is provisioned to multiple child companies.

Overview of MFT process

- Customer must submit comma delimited .csv files in the same format as if uploaded via IIA
- MFT will move files to be processed by IIA and immediately delete the file from the customer's folder
- IIA will process the files and generate .success and .error file receipts
- MFT will move .success and .failure files to the customer's respective /receipts folder
- Success files will contain all successful rows
- Error files will contain all errors for each failed row
- These files will be purged after 15 days

1.9 PENDING SHORT CODES AND PROFILES

All Short Codes and Profiles <u>must be registered prior to submitting on a Trade or Order</u>. Order and Trade submissions are validated against known unregistered Short Codes and Profiles. First time submissions of unregistered Short Codes and Profiles via the API will create Pending Short Codes and Profiles. All pending codes must be registered in the ICE Identifier Admin prior to the nightly <u>maintenance window</u> so that daily regulatory reporting can be completed.

1.9.1. PENDING SHORT CODE AND PROFILE REPORT

In order to assist companies in identifying their pending Short Codes and Profiles, under the Reports file menu, there will be a report for 'Pending Short Codes' and 'Pending Profiles'. **This report shows all pending data entered from the previous day at 1800 ET.**

IIA users will have the ability to register email addresses that they want the pending Short Code and Profile email notifications to be sent to. The email will contain a summary of pending data for all child companies associated to that email address. That is, **the number of pending Profiles and the number of each type of Pending Shorts codes from the previous day at 1800 ET** will be included.

The email will be run six times daily, Monday through Friday:

- 0200 ET
- 0700 ET
- 1200 ET
- 1700 ET
- 1800 ET
- 2100 ET

1.11 SHORT CODE/NEW ORDER ATTRIBUTE SCENARIOS

1.11.1 **MEMBER**

All Exchange Members are required to set up Short Codes for their Algos, Traders and Clients within IIA. Clients of Exchange Members are identified by LEI if a legal entity or a Personal Identifier if an individual.

- Liquidity Provision flag = Y/N
- Commodity Derivatives Indicator = Y/N
- Execution decision short code = Algo code or Trader info

Member executing non-DEA Client business where the Member makes no decisions but simply executes the Client's instructions

- DEA flag = N
- Trading capacity = AOTC
- Liquidity Provision flag = Y/N

- Investment Decision short code = blank
- Client short code = Client LEI

Member executing House proprietary business into the Member entity

- DEA flag = N

- Client short code = LEI of Member (exchange will default so not necessary to supply)

- Trading capacity = AOTC
- Liquidity Provision flag = Y/N
- Commodity Derivatives Indicator = Y/N
- Execution within Firm short code = Algo code or Trader info for the Member not the affiliate
- Investment Decision short code = Algo code or Trader info for the Member not the affiliate
- Client short code = LEI of the affiliate

1.11.2 NON-MEMBER

Non-Members (working together with their Member) will have minimal setup within IIA.

- Non-Members/DEA users provide the order attributes from the perspective of their Member
- Non-Members/DEA users only need to setup one Short Code for 'Client Identification Code' that contains their company's LEI (no trader personal information is required)
- The Short Code for 'Execution within Firm' is always the reserved Short Code 3 (which represents 'NORE')
- The Short Code for 'Investment Decision within Firm' is not applicable

Therefore, Non-Members have one scenario for the additional MIFID data needed on an order:

- DEA flag = Y
- Trading capacity = AOTC
- Liquidity Provision flag = Y/N
- Commodity Derivatives Indicator = Y/N
- Execution within Firm (EwF) short code = NORE (reserved Short Code already created for each company)
- Investment Decision (ID) short code = (blank)
- Client short code = LEI of the DEA user

When DEA = Y and Trading Capacity = AOTC then EwF must be reserved short code '3'.

1.12 DATA SNAPSHOT FOR ORDER RECORD KEEPING AND TRANSACTION REPORTING

The underlying data behind a Short Code or the Profile ID can be changed throughout the day; however, the underlying data will be "snapshot" at the start of the nightly <u>maintenance window</u>, and all order and trade records that reference those Short Codes and Profiles will reference that "snapshot" for the day's MiFID reporting obligations.

1.13 CLEARING FIRM ACCESS

When a Clearing Firm user logs into IIA, he can use the Company dropdown in the upper righthand corner to switch the view to:

- Companies that the Clearing Firm has created
- Companies that are Customers of the Clearing Firm (i.e. Clearing Firm has issued a system managed Clearing Account to the company or the Clearing Firm is the Default Clearer for the company)

Customers appear first in alphabetical order and are pre-pended with an * asterisk. Companies that have been created by the Clearing Firm appear after the Customers, also in alphabetical order.

The access of the Clearing Firm userID (view or edit) applies the same to all Companies in the dropdown. Clearing Firm users will only be able to view Short Codes entered directly by the Companies or entered by their Clearing Firm. They will not be able to view Short Codes entered by other Clearing Firms.

1.14 IMPLICATIONS TO TRADING

1.14.1. WEBICE

In WebICE, a new dropdown, Compliance Profile, has been added to the Order Entry screens. All Profiles associated to a userID via IIA as previously described in this document will be displayed in this dropdown. In addition, the user can enter the seven MIFID related data points directly clicking the '+' icon next to the Compliance Profile dropdown which opens a new window. Users can save 'named combinations' of the seven MIFID data points, and these 'named combinations' will also appear in the Compliance Profile dropdown along with Profiles from IIA.

All Short Codes and Profiles must be registered in IIA prior trading.

Users cannot enter an order in a MiFID eligible market unless they select a valid Profile from IIA, a 'named combination' or enter the seven data points directly.

To walk through the impact, below is a screenshot of the new Compliance Profile dropdown of a userID that has three Profiles assigned to his userID from IIA.

The user can click the '+' icon to deploy the 'Create MIFID Profile' window to enter the seven MIFID data attributes directly as well.



Once the user has entered the data, the user has the option to 'name' the set of attributes using the 'Save As' checkbox. In the example below, the user has entered 'Customer 4444' as the name.

Clicking apply will save the 'named combination' and return the user to the Order Entry screen with 'Customer 4444' selected as the Compliance Profile. *Please note that if the combination is not named/saved, it will simply appear as a concatenated string of data in the Compliance Profile dropdown (e.g. AOTC | 1111 | 0 | 4444).*

Once the data points have been given a 'name', the name will appear on the left-hand side of the 'Create MIFID Profile' window and can be edited.

Please note that Profiles created via IIA cannot be edited. They will not have a 'x' button to delete nor can any of the data points be changed. However, the user can select an IIA Profile to see the seven individual data points (and the user could even use that data as a template to save another 'named combination' if so desired).

A default Profile or a default 'named combination' can be assigned per Portfolio by right-clicking the Portfolio, selecting 'Select Compliance Profiles' and then choosing a value from the 'Default' dropdown.

The 'Create MIFID Profile' window can also be deployed from the Portfolio by clicking the '+' button to add/edit/delete 'named combinations'.



Once a Portfolio default is save, that Profile will automatically appear as selected in the new 'Compliance Profile' dropdown, but the user can always choose a different Profile (or enter new data directly by clicking the '+" icon).

Additionally, a 'Compliance Profile' column has been added to the Orders and Deals tabs within WebICE. Compliance Profiles, 'named combinations' or new data altogether can be updated on orders or trades by selecting a new value or selecting 'New' and entering new data from the 'Create MIFID Profile' window deployed (same as from the Order Entry screens and the Profile default).

FIX users can send the seven individual MiFID values (tag 9700-9706) on order and mass quote messages, or FIX users can send the single value (tag 9707) value on order and mass quote messages. Tag 9707 is the Profile described in previous sections in this document that represents a predefined combination of the seven MiFID values.

In addition to sending data in on orders, FIX users can set default MiFID values on Trader Logon (these values will be used for all orders for the session).

The FIX messages below require the new tags when the market is 'MiFID Eligible'. If the validations are not met, the order will be rejected.

- 35 = D, New Order Single
- 35 = G, Cancel Replace Order (Values should be updated on the order in case of a change)
- 35 = J, Allocation
- 35 = i, Mass Quote (One set of values for the whole Quote)
- 35 = s, Crossing Order (Values should be present for both sides)
- 35 = CG or UCG, Trader Login (Default values for the trader)

Other key FIX OS points:

- If the market is not 'MiFID Eligible', there will be no MiFID validations performed, and the values will not be echoed out on FIX TC or FIX POF
- Tags 9700-9706 are not needed on order messages if defaults are provided at Logon
- MiFID tags on the order will take precedence over the default values sent at Logon
- If a Trader provides all or a subset of the seven individual tags (9700-9706) and a MiFID ID (9707), the MiFID ID (9707) will take precedence

1.14.3 ICE BLOCK

In ICE Block, a new dropdown, 'Compliance Profile', has been added to the trade ticket. Once a Company and User have been selected, the Profiles associated to that userID from IIA will be displayed (as previously described in this document). In addition to the Compliance Profile dropdown, clicking the + sign next to the Compliance Profile opens a window that will allow the user to enter the seven data points directly.

The ICE Block user may optionally select a Profile or enter the seven data points when entering an off-exchange trade. *Please note if the ICE Block user is entering an RFC, the Profile or seven data points will be required because the RFC generates an order which the Exchange is responsible for reporting.*

1.14.4 TRADE REGISTRATION API (TRAPI)

TRAPI Clients can optionally provide the MiFID data on trade registration. However, if they do provide the MiFID data, only a valid Profile ID that has been created and associated to the UserID in IIA will be accepted. If an invalid Profile ID is supplied, the trade will be rejected.

1.14.5 ACE

A 'Compliance Profile' column has been added to the Orders and Deals tabs within ACE.

1.15. COMPANY PORTAL

The Company Portal is available in the ICE Identifier Admin application for all trading member companies. The Company Portal includes a view of the existing company level data for all trading member entities to verify and request updates for the attributes related to MiFID reporting: legal entity identifier (LEI) and the MiFID Investment Firm status. This view will ensure accuracy for the Exchange to fulfill its own reporting obligations.

1.15.1. USER ACCESS

The Company Portal is available in IIA under the *Companies* tab. All existing trading member user ids that can access IIA will have access to view the new tab. Updating information on this tab requires additional access. Please contact <u>Compliance-Europe-</u> <u>MiFIDReporting@Thelce.com</u> to request access.

Note: Clearing Firm users will not have access to the Companies tab.

- 1. *Companies Dropdown*: All Trading Member companies will be listed in the tab. Additional filtering within entities is not required. The companies drop down is disabled and defaults to display 'All Companies'.
- 2. *Filter and Export*: Company names and LEIs can be filtered by typing all or part of the value in the filter entry box. Exports are available and will include all available Companies (not filtered).
- 3. *Company*: The Company column lists all Trading Member companies registered to trade within MiFID markets.
- 4. *Existing LEI & Existing MiFID Investment Firm Status:* Displays the existing values for the LEI and Investment Firm status on file with ICE Admin. This is the information that requires verification.
- 5. *Action:* View only users will only have access to the Audit Logs (\blacksquare) for each company. Users with write access will have options to Verify (\boxdot) or Request Update (\boxdot).
- 6. *Verification Status:* Indicates the current status of the Existing data.
 - a. Unverified: Associated Company requires action. If the Existing data is accurate then Verify (^{CC}). If the Existing data is incorrect then Request Update (^{CC}).
 - b. *Pending Approval:* Updates require ICE Compliance approval. This status will show after submitting an Update Request.
 - c. *Rejected:* ICE Compliance has rejected the update request. User should submit an updated request or verify the existing data.
 - d. *Completed:* Indicates the existing data has been verified or the requested update has been approved and MiFID reports will reflect the new information listed in Existing data as of the date in the Completed Timestamp field.
- 7. Requested Data: Data pending approval from the most recent request.
- 8. *Completed Timestamp (GMT)*: Indicates the time the Existing data was Verified or the Requested Update was applied to the Company.

1.15.3. VERIFYING EXISTING DATA

This section outlines the steps for verifying the existing MiFID reporting data. Use these steps if the MiFID reporting data (LEI & MiFID Investment Firm status) associated with the company is correct.

Steps:

1. Select the Verify Existing Data icon ([≦]) for a Company with Verification Status *Unverified*

2. Review and confirm the Existing LEI and MiFID Firm Investment status values are correct in the Verify Existing Data window.



Note: If the MiFID data must be updated the Update option can be used from the Verify Existing Data window to launch the Update Existing Data window (detailed in next section).

3. Select Verify.



Once verified, the status will automatically update to *Completed*. The verification is now complete for this company.

Repeat steps 1-3 for additional companies in *Unverified* status that do not require an update.

2. OVERVIEW OF ERROR MGMT

ICE Identifier Admin (IIA) now supports correcting MiFID related errors to Orders and Transactions. The Errors Sets have previously been distributed to Trading Members via MFT in csv files. The new Error Management tab captures the same details as the MFT files with the added ability to define Short Codes and Profiles or remap the Error Set to a new Profile or Compliance Key.

Members can now view their errors on-line and make the necessary corrections on-line. The Exchange validates and processes the corrections overnight and if successful the error set will not be present on the error screen the following day.

3. ACCESSING ERROR MANAGEMENT

Users that currently have access to IIA with the ability to create short codes (i.e. write access) will automatically have access to the new Error Management tab. Clearers will have access to the Error Sets where the Clearer is listed on the Error Set for the Trading Company.

4. PROCESSING CORRECTIONS

Corrections can be applied throughout the business day. All Error Sets in 'Correction Pending' status at 5:50 PM ET will be processed during the daily maintenance window. When the maintenance window starts, the Error Management tab will be closed for submitting corrections and show the following banner:

The new list of Error Sets (if applicable) will be available by 2:00 AM ET for the start of business in Europe.

5. SUBMITTING CORRECTIONS

There are two ways to correct Error Sets:

- 1) Define short codes and/or profiles currently associated to the Error Set(s),
- 2) Update the Error Set(s) to a valid Profile or previously used Compliance Key (CKey).

1) DEFINING SHORT CODES OR PROFILES

To define the incomplete codes, simply select the codes within the Error Set that are in red text then fill in the correct information in the Define Short Code (or Define Profile) window. See IIA user guide for setting up short codes and profiles for complete details.

Once all undefined codes for an Error Set have been defined, the Correction Type will automatically update to 'Defined Pending Codes' with Correction Status updated to 'Correction Pending'.

Note: if the newly defined Short Codes or Profile ID are also associated to other Error Sets, the other Error Sets will also be processed with this correction.

2) UPDATE PROFILE OR CKEY

Mapping an Error Set to a different Profile or Ckey should be used if the originally submitted Short Codes or Profile ID currently associated to the Error Set were incorrectly submitted or if no MiFID data was submitted at all.

Tip: Companies that typically submit the 7 MiFID data points on orders or transactions can search the Compliance Key (Ckey) dropdowns for Short Codes or the Ckey value (if known) and select the applicable MiFID Configuration.

Companies that typically submit Profile IDs with orders or transactions can use the Profile dropdowns to correct the Error Sets.

Corrections can be made line by line or in bulk. Each Error Set allows the user to map either a new Profile or a new Ckey.

3) BULK UPDATES

Bulk updates can also be made by filtering on any column, displaying the Error Sets that should have the same correction, then using the Bulk Update Options at the top of the screen.

Compliance Key Dropdown: The available data in the Compliance Key dropdown consists of valid Raw Data (7 MiFID data points) previously submitted on Orders or Transactions. *Profile ID Dropdown:* To map an Error Set to a different Profile, search for and select the correct Profile in the dropdown associated to the Error Set in the Update Profile column. *Clear All* will clear all Profiles or Ckeys applied to the **visible (non filtered)** error sets.

4) DAILY CORRECTION COUNTS

The error counts in the top right of the tab capture the counts of Error Sets and sum of Error Count by Correction Status.

In the below example, 15 Error Sets will attempt to be Corrected during the next maintenance window. and those 15 Error Sets account for 1,752 Orders or Transactions.

338 Error Sets require action (by mapping a profile, ckey or defining the codes). The 338 Error Sets account for 105,383 Orders or Transactions.

Correction Pending:	15 (1752)
Action Required:	338 (105383)

Correction counts are reset daily and only account for the Error Sets shown on the Error Management tab for that specific day. Historical correction stats are not available.

6. ERROR MANAGEMENT COLUMNS

Columns on the Error Management tab can be collapsed, filtered, hidden and repositioned.

Tip: Use the column filters to display Error Sets that require the same correction then use Bulk Update.

Example 1, if all Error Sets for Trader John Smith should be mapped to Profile ID 4. Filter for John Smith on the Trader column. Select Profile ID 4 in the Bulk update Profile dropdown then select Apply All. Then clear the Trader column filter.

Example 2: After applying corrections, filter for 'Not Corrected' in Correction Type column to only display Error Sets that still require action.

To expand the field categories, select the arrow next to the category heading.

To update the column display settings, select the three lines on the column heading. To hide or display certain columns, select the column icon then check or uncheck the columns to display, hide. By default all columns will be displayed.
