### 11. POWER-CORD PROTECTION

### 12. LIGHTNING

To protect your unit from a lightning storm, or when it is left unattended and unused for long periods of time, unplug it from the wall outlet and disconnect the antenna or cable system. This will prevent damage to the unit due to lightning and power line surges. However, while it is thundering or lightning, do not touch the apparatus and any connected cable and/or equipment. ### 13. POWER LINES

### Precautions Notes on handling

- Do not subject the LCD panel to physical shock, such as dropping it. It may cause malfunction.
- Retain the original shipping carton and packing materials. Repack the unit as it was originally packed at the factory. For maximum protection when shipping.
- Do not use volatile liquids, such as insecticide, near the unit. Do not leave rubber or plastic products in contact with the unit for long periods of time. Doing so will leave marks on the finish.
- The top and rear panels of the unit may become warm after a long period of use. This is not a malfunction.
- When the unit is not in use, turn off the power.

### Notes on locating the unit

- Place the unit on a level surface. Do not use it on a shaky or unstable surface such as a wobbling table or inclined stand. Doing so may damage the unit.
- When you place this unit near a TV, radio, or VCR, the playback picture may become poor and the sound may be distorted. In this case, place the unit away from the TV, radio, or VCR.

### Notes on cleaning

Clean only with a soft, dry, lint-free cloth.

### Notes on LCD

- The color LCD is manufactured using extremely high precision technology, but even so may include certain pixels that do not operate properly (that do not light, that remain lit constantly, etc.). We do our best to keep the number of these defective pixels to a minimum, but please understand that they cannot be completely eliminated even with the most advanced manufacturing technologies available today.
- The fluorescent tube which illuminates the panel from the inside will deteriorate with use. When the LCD becomes dim, flickers, or does not illuminate, contact your dealer for replacement.
- The brightness of the LCD monitor differs slightly depending on the viewing angles. Adjust the angle to obtain the best viewing.




# **Exploring your New Monitor**

You can operate your Monitor by using the buttons on the front panel. The side panels provide the inputs to connect other equipment to your Monitor.

# Selecting a Location for the Monitor

- Place the Monitor on the floor or on a sturdy platform in a location where light does not directly hit the screen.
- Place the Monitor far enough from the walls to allow proper ventilation. Inadequate ventilation may cause overheating, which may damage the Monitor.


### Caution:

When using the back stand, please be careful since in some angles, the Monitor may fall over to the front. When using the back stand, please be careful not to catch your fingers between the folding stand. It may cause you unnecessary injury

# **Connecting your Monitor**

If you haven't connected electronic equipment before, or you have been frustrated in the past, you may wish to read this section. (Cables are not supplied.)

- Audio cables are usually color coded according to use: red and white for audio. The red audio cable is for the stereo
  right channel, and the white audio cable is for the stereo left (or mono) channel. If you look at the rear panel of the
  Monitor, you will see that the terminals are color coded in the same manner as the cables.
- S-video cables provide better picture performance than standard video cables. S-video cables can only be used with S-video compatible components.
- BNC cable provides better connection and picture performance.






### NOTE:

This connection allows you to watch DVR.



This connection allows you to watch camera.





# Connecting a PC (Personal Computer)

Before you connect this PC to your monitor, change the adjustment of your PC's Resolution and Refresh rate. See "Monitor Display modes".

Connect one end of a (male to male) VGA cable to the video port of the computer and the other end to the VGA connector at the back of the monitor. Fix the connectors firmly with the screws on the plug.

Turn on the computer and Monitor. The monitor can be operated as the computer monitor.




When adjusting to a rack, you will need to use an optional rack mount to the back side of the LCD monitor.

# Setting up your Monitor



1. Turning on the monitor

Press the POWER.: The power indicator lamp (green) will light and the image will be displayed. Press the POWER again.: The power indicator lamp (red) will light and the power will be turned off.


2. Switching the input source

Press the INPUT.: Each press will switch the source in order.

3. Selecting the mode and changing the adjusted value (when the MONITOR SETUP screen is displayed by using the MENU)

Press the UP/DOWN to select the mode and to change the adjusted value.

The SETUP feature appears the first time you turn on the Monitor, and helps you to select the menu language, specify the Monitor/CABLE setting, and program channels.



General Setup: Configure Language, Backlight, Power on Option, Power Latching,

Key Lock, Display and Volume functions.

Video Setup: Configure video signal Brightness, Contrast, Color, Hue, Sharpness, Color

Temperature, Video System and Over Scan functions.

PC-In Setup: Configure PC VGA signal Brightness, Contrast, H-Position, V-Position, Clock,

Phase, Color Temperature and White Balance functions.

Brightness: Adjust the overall picture shade and brightness.

Contrast: Provide adjustment for contrast between light and dark areas of the picture

When pressing the up down button, the number displayed will not be in serial order.

**Color:** Adjust the color gain on the screen.

Please note that the color will not be black and white when turning the number down to 0.

Hue: Adjust the color phase on the screen, (NTSC only)

When pressing the up down button, the number displayed will not be in serial order.

Sharpness: Set the desired sharpening enhancement to the picture


