



INSTALLATION AND OPERATION MANUAL FMCI-AF1/BF1 Series 10/100MBPS ELECTRICAL TO OPTICAL ETHERNET MEDIA CONVERTERS

FMCI-AF1MM1STM FMCI-BF1MM1STM FMCI-AF1SM1STM FMCI-BF1SM1STM FMCI-AF1MM1ST FMCI-BF1MM1ST FMCI-AF1SM1ST FMCI-BF1SM1ST The FMCI-AF1/BF1 media converters convert 10/100Mbps Fast Ethernet from an electrical signal to an optical signal and back to an electrical signal. The electrical connection uses an RJ45 data connector.

Depending on the specific model in use, the optical connector is either a ST or SC, 1 or 2 Fibers, multimode (MM) or singlemode (SM), and the unit operates on either AC/DC or DC only power.

The standard size units may be directly plugged into the Rack (Pelco Part US-RACK or EU-RACK) or operated as a standalone module. The small size units operate as standalone modules only.

- 1. Read these instructions.
- 2. Keep these instructions.
- 3. Heed all warnings.
- 4. Follow all instructions.
- 5. Do not use this apparatus near water.
- 6. Clean only with dry cloth.
- 7. Do not block any ventilation openings. Install in accordance with the manufacturer's instructions.
- 8. Do not install near any heat sources such as radiators, heat registers, stoves, or other apparatus (including amplifiers) that produce heat.
- 9. Do not defeat the safety purpose of the polarized or grounding-type plug. A polarized plug has two blades with one wider than the other. A grounding type plug has two blades and a third grounding prong. The wide blade or the third prong are provided for your safety. If the provided plug does not fit into your outlet consult an electrician for replacement of the obsolete outlet.
- 10. Protect the power cord from being walked on or pinched particularly at plugs, convenience receptacles, and the points where they exit from the apparatus.
- 11. Only use attachments/accessories specified by the manufacturer.
- 12. Use only with the cart, stand, tripod, bracket, or table specified by the manufacturer, or sold with the apparatus. When a cart is used, use caution when moving the cart/apparatus combination to avoid injury from tip-over.
- 13. Refer all servicing to qualified service personnel. Servicing is required when the apparatus has been damaged in any way, such as power-supply cord or plug is damaged, liquid has been spilled or objects have fallen into the apparatus, the apparatus has been exposed to rain or moisture, does not operate normally, or has been dropped.
- 14. Apparatus shall not be exposed to dripping or splashing and that no objects filled with liquids, such as vases shall be placed on the apparatus.
- 15. WARNING: To reduce the risk of fire or electric shock, do not expose this apparatus to rain or moisture.
- 16. Installation should be done only by qualified personnel and conform to all local codes.
- 17. Unless the unit is specifically marked as a NEMA Type 3, 3R, 3S, 4, 4X, 6, or 6P enclosure, it is designed for indoor use only and it must not be installed where exposed to rain and moisture.
- 18. Use only installation methods and materials capable of supporting four times the maximum specified load.
- 19. A CCC-approved power cord must be used to power this equipment when used in China.
- 20. In order to satisfy the EU Regulatory compliance Standards, the use of a universal power supply (UPS) is required on the AC mains.
- 21. **CAUTION:** These servicing instructions are for use by qualified service personnel only. To reduce the risk of electric shock do not perform any servicing other than that contained in the operating instructions unless you are qualified to do so.

FIGURE 1 – FMCI-(A,B)F1(SM,MM)1ST SERIES STANDARD SIZE UNIT




FIGURE 2 - FMCI-(A,B)F1(SM,MM)1ST SERIES STANDARD SIZE UNIT




FIGURE 3 – FMCI-(A,B)F1(MM,SM)1STM SMALL SIZE UNIT






FIGURE 4 – FMCI-(A,B)F1(MM,SM)1STM SMALL SIZE UNIT







INSTALLATION CONSIDERATIONS

The FMCI-(A,B)F1(MM,SM)1ST media converters are supplied as Standalone/Rack modules. The FMCI-(A,B)F1(MM,SM)1STM small size media converters are supplied as Standalone/Surface Mount modules. Units should be installed in dry locations protected from extremes of temperature and humidity.

CARD CAGE RACKS

CAUTION: Although the units are hot-swappable and may be installed without turning power off to the rack, the manufacturer recommends that the power supply be turned off and that the rack power supply is disconnected from any power source. Note: Remove electrical connector before installing in card cage rack.

 Make sure that the card is oriented right side up, and slide it into the card guides in the rack until the edge connector at the back of the card seats in the corresponding slot in the rack's connector panel. Seating may require thumb pressure on the top and bottom of the card's front panel.

CAUTION: Take care not to press on any of the LEDs.

- 2. Tighten the two thumb screws on the card until the front panel of the card is seated against the front of the rack.
- WARNING: Unit is to be used with a Listed Class 2 power supply.

IMPORTANT SAFEGUARDS:

- A) Elevated Operating Ambient If installed in a closed or multiunit rack assembly, the operating ambient temperature of the rack environment may be greater than room ambient. Therefore, consideration should be given to installing the equipment in an environment compatible with the maximum ambient temperature (Tma) specified by the manufacturer.
- B) Reduced Air Flow Installation of the equipment in a rack should be such that the amount of air flow required for safe operation of the equipment is not compromised.

Dimensions are for a standard one slot module




PRODUCT WARRANTY AND RETURN INFORMATION

WARRANTY

Pelco will repair or replace, without charge, any merchandise proved defective in material or workmanship **for a period of one year** after the date of shipment.

Exceptions to this warranty are as noted below:

- Five years:
 - Fiber optic products
 - Unshielded Twisted Pair (UTP) transmission products
 - CC3701H-2, CC3701H-2X, CC3751H-2, CC3651H-2X, MC3651H-2, and MC3651H-2X camera models
- Three years:

 - Fixed network cameras and network dome cameras with Sarix® technology
 - Sarix thermal imaging products (TI and ESTI Series)
 - Fixed analog camera models (C20 Series, CCC1390H Series, C10DN Series, and C10CH Series)

 - Spectra[®] IV products (including Spectra IV IP)
 - Spectra HD dome products
 - Camclosure® IS Series integrated camera systems
 - DX Series video recorders (except DX9000 Series which is covered for a period of one year), DVR5100 Series digital video recorders, Digital Sentry[®] Series hardware products, DVX Series digital video recorders, and NVR300 Series network video recorders

- Six months:
 - All pan and tilts, scanners, or preset lenses used in continuous motion applications (preset scan, tour, and auto scan modes)

Pelco will warrant all replacement parts and repairs for 90 days from the date of Pelco shipment. All goods requiring warranty repair shall be sent freight prepaid to a Pelco designated location. Repairs made necessary by reason of misuse, alteration, normal wear, or accident are not covered under this warranty.

Pelco assumes no risk and shall be subject to no liability for damages or loss resulting from the specific use or application made of the Products. Pelco's liability for any claim, whether based on breach of contract, negligence, infringement of any rights of any party or product liability, relating to the Products shall not exceed the price paid by the Dealer to Pelco for such Products. In no event will Pelco be liable for any special, incidental, or consequential damages (including loss of use, loss of profit, and claims of third parties) however caused, whether by the negligence of Pelco or otherwise.

The above warranty provides the Dealer with specific legal rights. The Dealer may also have additional rights, which are subject to variation from state to state.

If a warranty repair is required, the Dealer must contact Pelco at (800) 289-9100 or (559) 292-1981 to obtain a Repair Authorization number (RA), and provide the following information:

- 1. Model and serial number
- 2. Date of shipment, P.O. number, sales order number, or Pelco invoice number
- 3. Details of the defect or problem

If there is a dispute regarding the warranty of a product that does not fall under the warranty conditions stated above, please include a written explanation with the product when returned.

Method of return shipment shall be the same or equal to the method by which the item was received by Pelco.

RETURNS

To expedite parts returned for repair or credit, please call Pelco at (800) 289-9100 or (559) 292-1981 to obtain an authorization number (CA number if returned for credit, and RA number if returned for repair) and designated return location.

All merchandise returned for credit may be subject to a 20 percent restocking and refurbishing charge.

Goods returned for repair or credit should be clearly identified with the assigned CA or RA number and freight should be prepaid.
