








CONNECTING DIVERTER TO FAUCET

- · Parts Included: Faucet mount system, cartridge, faucet adapters, filter change eminder label
- Remove the aerator from the faucet on which the filter will be installed (Fig. 1)
- Determine the type of threads on your faucet and the need for an adapter. For faucets with outside threads, no adapter is needed. For faucets with inside threads, an adapter is needed (Fig 2). Use appropriate size from parts included.
- 3. Select the proper adapter (if needed) and washers. Screw into faucet and tighten manually (Fig 3).
- Attach the diverter to the faucet and turn until tight (Fig 4). To ensure snug fit, grasp the diverter and the body and turn them
 together clockwise. Then, holding the diverter still, turn the body clockwise until the unit is aligned to the left of your faucet (Fig 5).
- 5. Run water 5 minutes to flush the filter cartridge. Then b ore each use, run for 1-2 seconds to flush



IMPORTANT INFORMATION

- DO NOT RUN HOT WATER through unit. For COLD WATER USE ONLY. Turn on cold water faucet (about one third of the way open). To receive filte ed water, turn diverter valve handle on (Fig 6).
- DO NOT run water through at maximum flo . Slow flow will extend contact time between the filtration media and wate , which results in better filtration. Keep flow below .30 GPM for fil tion to be effective.*
- 3. DO NOT use where water is microbiologically unsafe.
- 4. DO NOT cross-thread. If cross-threaded, do not put unit into service
- 5. Make sure that installation of this system complies with all state and local laws and regulations.
- Contaminate or other substances removed or reduced by this system are not necessarily in your
- If system is not used for an extended period of time, allow water to run for 5 minutes prior to use re-flush the system
- If you need to connect a portable dishwasher to your faucet, unscrew the aerator from the filter and attach according to the manufacturer's recommendations.
- A Reminder Decal is provided for your use to record the installation and filter eplacement dates.
 Peel off sticker and affix to the corner of a dry mir or or any glass service.
- 10. One-micron filtration will trap all invisible and undetected sediment, rust, and microorganisms. It is recommended that you replace the pre-filter pad to avoid clogging. In certain geographical a eas the pre-filter pad may need to be eplaced more often.
- 11. For more information refer to other labels and/or Installation and Operation Guide.
- Do not use non-Crystal Quest® replacement cartridges.
- Do not use non-Crystal Quest[®] parts or modify/tamper with unit.

REPLACEMENT CARTRIDGE (CAPACITY: 2,000 GALLONS)* (6-12 MONTHS FILTRATION)*

Your Faucet Mount Water Filter system contains a cartridge that must be replaced at regular intervals to maintain proper performance.


- The filter cartridge has a limited service life, use only factory approved cartridges.
- Changes in taste, odor, and flow of the water being filt ed indicate that cartridge should be replaced. Failure to change the
 cartridge routinely will result in reduced performance and void the warranty.
- Flush each new filter cartridge 5-10 minutes to emove all media fines. Media fines e not harmful but should be flushed out befo e
 using the filte ed water.
- . Cartridge may need to be rotated quarterly to backwash and dechannelize the system (Fig 1, #4).
- 1. Disconnect filter housing unit by unsc ewing diverter valve (Fig 7, #7) from faucet.
- 2. Separate the filter housing by turning upper filter housi (Fig 7, #1) counterclockwise to open.
- 3. Remove cartridge (#4) from lower filter housing along with the ha d white disk and soft clear inner disk (Fig 7, #5).
- Take cartridge out of wrapping, replace old cartridge with new one, and install cartridge with micron pad (Fig 7, #3) showing at the
 top. Reassemble filter housing unit following install tion instructions.
- 5. Run water through unit for 5-10 minutes prior to first use and 2-3 seconds b fore each use thereafter.

*Cartridge life varies with water condition and consumption.

CARE AND OPTIMUM USE

The replacement cartridge can be used inversely to extend lifetime. Flip the cartridge to the opposite side of the housing unit to allow water to flow in op osite direction. This backwashes the filter and p events channeling.

- Follow Steps 1-3 for replacing cartridge. (Removal of disks (Fig 7, #5) may take some prying.)
- Move micron pad (Fig 7, #3) to the other end of cartridge. (This end becomes the top end of the cartridge.)
- 3. Insert disks into the bottom end of the cartridge.
- 4. Place cartridge into lower portion of housing unit and push firmly to secule.
- 5. Reattach upper filter housing (Fig 7, #1) and tighten clockwise
- 6. Run water for 3-5 minutes.
- Wash the filter housing unit monthly with mild dete gent and rinse with hot water. If hard water buildup is present on the diverter valve, soak valve in vinegar 5 to 15 minutes.



TROUBLESHOOTING

- 1. Water flow has drastically educed. The unit may be clogged. Change micron pre-filter pad or eplace the cartridge.
- Water leak between the base and sump of the housing unit.
 - · The unit may be clogged
 - · The filter cartridge is not installed p operly
 - · The O-ring on the top housing needs to be replaced
 - · Water pressure is too high. Reduce flo .
- Water leaks around faucet and diverter area. Make sure the diverter is tight. Use the correct adapter or diverter O-ring included with the filter housing unit. If necessar , replace the diverter.
