

Guide to Variables for SNAP Administrative Data available through a Federal Statistical Research Data Center (FSRDC)

Abstract. USDA's Supplemental Nutrition Assistance Program (SNAP) provides nutrition benefits to supplement the food budget of needy families. This guide provides: a description of the types of data collected by State SNAP agencies from SNAP applicants; a list of which States have restricted-use, micro-level SNAP administrative data accessible through a Federal Statistical Research Data Center (FSRDC) and that have a publicly available list of variables in the data; a list of which variables are available for a particular State for a selected year; and an appendix that describes SNAP Quality Control (QC) data.

1. Background

USDA's Supplemental Nutrition Assistance Program (SNAP) provides nutrition benefits to participating households. SNAP households are formally known as "SNAP units," which helps to distinguish between a group of people who together receive SNAP benefits (the SNAP unit) from a group of people who live at the same address (in a "household" in Census Bureau terminology). SNAP units receive monthly benefits that can be used to purchase food items at authorized SNAP retailers.

USDA's Food and Nutrition Service (FNS) administers the Supplemental Nutrition Assistance Program (SNAP) in partnership with State SNAP agencies. Some State SNAP agencies provide an extract of some of the State's SNAP administrative data to the U.S. Census Bureau for statistical and research purposes. Most of the SNAP administrative data that the Census Bureau possesses have been acquired since 2012 as part of the *Census-FNS-ERS Joint Project*, a cross-agency collaboration between the State SNAP agencies, the Census Bureau, and USDA's Food and Nutrition Service (FNS) and Economic Research Service (ERS). The SNAP administrative data held at the Census Bureau are micro-level, restricted-use data that are subject to many safeguards to protect data confidentiality and to ensure that data are used only for approved purposes. Academic researchers can request access to these SNAP administrative data through a Federal Statistical Research Data Center (FSRDC). To obtain access, a researcher must have an approved project and be granted Special Sworn Status (SSS) by the Census Bureau. To prepare a proposal that may be suitable for approval, researchers benefit from information about the availability of SNAP administrative data; researchers also benefit from working closely with an FSRDC Administrator, who can answer procedural questions not addressed by this manual. Researchers who lack SSS may still submit a proposal for approval and then apply for SSS if the proposal is approved.

To aid researchers in preparing proposals, some information can be shared publicly about restricted-use SNAP administrative data:

- (1) the States and the (calendar) years for which SNAP data are available (for approved projects by researchers with SSS); and
- (2) the variables that are on a State's data SNAP data file.

The manual's appendix provides a general description of the types of data collected by State SNAP agencies from SNAP applicants by examining the SNAP Quality Control (QC) system and its variables

Other resources that can provide background and insight on the use of SNAP administrative data include Czajka and Cunnynggham (2016) and Czajka et al. (2015).

2. List by State/years of SNAP data available through FSRDCs

Some States make restricted-use micro-level SNAP data and lists of variables available for research through an FSRDC and have a public list of variables that academic researchers can use to develop proposals to access the data. See Table 1 below for a list of States.

3. Variables in SNAP Administrative Data, by State¹

While States typically provide several (calendar) years' worth of data to the Census Bureau, the list of SNAP variables provided in this manual is for a given State for a single selected year. It is highly likely, but not a certainty, that the same variables are available for other years of SNAP data provided by that same State; the variables a State provides are outlined in an agreement between the State and the Census Bureau, and that agreement is subject to revision from time to time.

It is noted that the SNAP administrative data held at the Census Bureau contain more variables than those that are sent by the State SNAP agency. The Census Bureau itself adds variables to the file to enhance the file's research uses. In particular, a variable known as the *Protected Identification Key* (PIK) is an individual-specific number, assigned by the Census Bureau, that serves as the linking variables between an individual's data in SNAP administrative data and that same individual's data in other Census data products, such as the American Community Survey. For further information on PIKs and the PIKing process, see Wagner and Layne (2014).

As shown in the lists below, files with names that include "rsch" include the variables sent from the states, while files with names that include "pvs" include the unique identifiers as assigned by the Census Bureau. These two types of files can be linked using a linking variable.

Appendix A. Variables in SNAP Quality Control (QC) Data

The data management system of a State SNAP agency collects a wide variety of information from SNAP applicants that are necessary for administration of the program, including the determination of eligibility for SNAP benefits and of the amount of SNAP benefits. The monthly SNAP benefit for a participating SNAP unit: (1) increases when the SNAP unit has more people, and (2) decreases when the SNAP unit has more of its own resources (as measured by “Net Income”—a definition or measure of income that takes into account certain allowable deductions from a SNAP unit’s monthly Gross Income).

A State SNAP agency provides the Census Bureau an *extract* of the SNAP administrative data in its system. That extract can include many or few of the variables in the State’s data management system. As a result, the extracts of SNAP administrative data files received by the Census Bureau contain different variables for different States; some States provide more variables than others.

A representation of the general types of variables in a State’s SNAP data management system—which may or may not be included in a given State’s SNAP data at the Census Bureau—can be found in SNAP Quality Control (QC) data. As described by FNS:

“The SNAP Quality Control data are an edited version of the raw data file generated by SNAP’s QC System, which is composed of monthly case reviews conducted by State SNAP agencies. The SNAP QC data contain detailed demographic, economic, and SNAP eligibility information for a nationally representative sample of SNAP participants. The data, produced annually, are well suited for tabulating characteristics of SNAP participants.” (Food and Nutrition Service, 2019).

Thus, the SNAP QC data originate in the State SNAP administrative data systems, as do the extract of the SNAP administrative data held at the Census Bureau.

There are some differences between QC data and the SNAP administrative data available through FSRDCs. The SNAP QC represent a *sample* of data drawn from administrative records. In contrast, the SNAP administrative data files are a *census* of data—the extract may not include all variables from the system, but it is intended to include all SNAP participants (the universe of

SNAP participants in a State). SNAP QC is used to calculate error rates for State SNAP agencies by collecting up-to-date data on a sample of SNAP participants. Thus, the SNAP QC data also contain many variables recording the corrections made to participant cases. The SNAP QC data are designed to be nationally representative; the SNAP administrative data are provided by States that choose to participate. Despite these differences, the types of demographic, economics, and SNAP-eligibility variables that are in the SNAP QC data are indicative of the types of variables in the SNAP administrative data, at least for those States that provide a highly complete set of variables to the Census Bureau.

The SNAP QC data are well-documented. The SNAP administrative data do not all have documentation as thorough as the documentation of the SNAP QC data, which makes familiarity with the documentation of the SNAP QC data valuable even when a researcher plans to use the SNAP administrative data for research.

A recent SNAP QC report is *Technical Documentation for the Fiscal Year 2019 Supplemental Nutrition Assistance Program Quality Control Database and the QC Minimodel FINAL REPORT* (Cronquist, et al., 2020). The associated codebook of SNAP QC variables provides the variable name, origin, label, range of values, and a list of values or description; this information is provided in **Appendix B (Quick-reference codebook for SNAP Quality Control Data (2019))** of this manual.

As shown in Appendix B, the variables in the SNAP QC data are classified as *unit-level variables* (which refers to the “SNAP unit,” sometimes known as the “SNAP household”), *person-level variables*. The variables are further subdivided for a total of nine categories:

- A. *Unit-level variables*: 1. Unit-level QC review administrative data; 2. Unit-level demographics and sample weights; 3. Unit-level countable income; 4. Unit-level countable assets; 5. Unit-level expenses and deductions; 6. Unit-level benefits
- B. *Person-level variables*: 7. Person-level characteristics; 8. Person-level income
- C. *Detailed error findings variables*: 9. Detailed error findings

In Appendix B, the column labelled Origin indicates whether the SNAP QC variable constitutes raw data (R) or is a constructed variable (C).

In addition to the “quick reference” codebook replicated in Appendix B, the QC documentation provides a “detailed” codebook” that adds a fuller description including information on valid values.

The SNAP administrative data will not have variables in all of the categories listed above, some of which are specific to the SNAP QC data. Nevertheless, the *file structure* of a State’s SNAP administrative data at the Census Bureau can be expected to consist of several files, with some files holding unit-level variables and others containing person-level variables.

It is noted that State naming conventions for variables differ across States. As a result, the names of variables in the SNAP administrative data will not all correspond to the names of the variables in the SNAP QC data even when both names represent the same “field” or variable in a State’s data management system.
