Dear Valued Customer,

This notification is to provide information regarding a change to the Fetal Bovine Serum product (FBS), as per our customer notification requirements.

Description of Change:

Minor change to the SKUs for Australian Origin China Eligible Fetal Bovine Serum

Purpose of Change:

To enhance product integrity, differentiation and traceability and assuring compliance to export requirements.

The minor change to the SKU is to ensure that we can segregate and identify China eligible products from non-China Eligible products to ensure compliance to requirements for exporting blood products into China. This will be achieved by adding a "C" suffix to all existing SKU's of Australian origin FBS supplied to the China market.

Detailed Description of Change:

The product labels for Australian Origin China Eligible Fetal Bovine Serum will now have suffix "C" to identify and differentiate product as China Eligible from non-China eligible. Please refer to table below for SKUs impacted:

The SKU change will come into effect for all product manufactured from November 27, 2018 onwards.
