




# Protect Yourself from Pesticides – Guide for Agricultural Workers (Filipino—Tagalog)

## Pangalagaan Ang Sarili sa “Pesticides” Pamatnubay sa Mga Manggagawa sa Bukid



**The Environmental Protection Agency** revised the Worker Protection Standard for agricultural pesticides in August 1992. The revised Worker Protection Standard requires that agricultural workers be given training in basic pesticide safety.

*Protect Yourself from Pesticides: Guide for Agricultural Workers* was developed by the Environmental Protection Agency; it presents all of the information required for training under the Worker Protection Standard. Some States and Tribes have additional requirements for pesticide safety training for agricultural workers. Contact the State or Tribal agency responsible for pesticide enforcement in your area to obtain information needed to comply with all State or Tribal training requirements.

There are other materials about the Worker Protection Standard that are being developed by EPA. They include a safety poster, a handbook on pesticide safety for pesticide handlers, and a manual for agricultural employers. Noong Agosto 1992 ay binago ng EPA ang "Worker Protection Standard" para sa paggamit ng "pesticides" ng mga manggagawa sa bukid. Sa bagong "Worker Protection Standard" ay kinakailangang ang bawat manggagawa sa bukid ay maturuan ng maingat at wastong paggamit ng "pesticides".



## Pesticide Safety Pangangalaga sa “Pesticides”



■ Pesticides help control pests, but they can also hurt—even kill—people.

Pesticides control pests such as insects and weeds. Pesticides can also hurt—even kill—people. The law helps protect you from pesticide poisoning. You can also help protect yourself.

□ Ang “pesticides” ay tumutulong sa pagpawi ng mga salot sa halaman, subalit ito ay nakasasama rin at maaaring makamatay ng tao.

Ang “pesticides” ay mahusay na pamatay ng mga insekto at masukal na damo. Ang pesticides ay maaari ding makamatay ng tao. May batas na makatutulong upang hindi makalason ang “pesticides.” Tulungang mapangalagaan ang sarili.

**■ Learn how to protect yourself. If you don't understand, ask for help.**


If pesticides are used where you work, your boss must make sure you are trained in pesticide safety.

This book has facts about pesticide safety. If you do not understand this book or your safety training, ask for help.

**□ Matutong pangangalagaan ang sarili. Humingi ng tulong kung hindi maintin dihan ang dapat sundin sa paggamit ng "pesticides"**

Ang sinumang gagamit ng "pesticides" sa trabaho ay kinakailangang maturuan nang wasto at maingat na pagamit nito. Dapat siguraduhin ng bawat amo na ang kanyang manggagawa ay nakapagsanay sa pangangalaga sa "pesticides."

## How Can You Protect Yourself From Pesticides? Papaano Mapapangalagaan ang Sarili sa "Pesticides"?



### ■ Wear clothes that cover your skin.

You should wear clean work clothes each day that will cover your skin:

- Long pants.
- A long-sleeved shirt.
- Shoes and socks.

### □ Magsuot ng damit na matatakpan ang balat.

Kailangang magsuot ng malinis na damit na matatakpan ang balat sa araw-araw.

- Mahabang pantalon
- Mahabang manggas
- Sapatos at medyas

## ■ At work, look for soap and water.

At work, you must be provided with soap, water, and towels if the areas where you work have had pesticides applied in at least the last 30 days. Pesticides dry on crops as a powder—this powder is the residue. A residue can remain on a crop many days after spraying.



### □ Maghanap ng sabon at tubig kung nasa trabaho.

Kinakailangan may sabon, tubig at tuwalyang magagamit sa trabaho, kung ang lugar na pinaggagawaan ay kadidilig lamang ng "pesticides". Ang natuyong "pesticides" ay nananatili sa halaman ng ilang araw matapos idilig.

Your hands and face may get pesticides on them.



- Stay out of areas where pesticides are being applied. If pesticides drift to where you are working, get out!

It is against the law for anyone to apply pesticides in an area where you are working, or to let pesticides drift onto you.

- Lumayo sa lugar na may naglalagay ng “pesticides”. Kapag umabot ang “pesticides” sa lugar na pinaggagawaan, lumayo ka agad!

Ipinag babawal ng batas kaninuman na mag lagay ng “pesticides” sa lugar na may nagsisigawa o pabayaang umabot sa kaninuman ang “pesticides” na idinidilig sa halaman.



### ■ If you see this sign, or ones like it, keep out!

This sign means that pesticides are in the area. You must have special training and protection to go into the area.



They are not safe for use around the home.




■ **Keep children away from areas where pesticides might be.**

At home, keep pesticides away from children.




■ After work each day, wash your whole body, including your hair.

Use plenty of soap and water. Then put on clean clothes.

**■ Keep dirty work clothes away from non-work clothes and from the family laundry.**

Pesticides may get on your clothes at work. Wash your work clothes, including your cotton gloves before using them again.

**□ Ihiwalay ang maruming damit naisinuot sa trabaho. Huwag pagsamahin ang lahat ng maruming damit na lalabahan.**

Maaring mapuno ng “pesticides” ang damit naisinusuo sa trabaho. Labahan ang damit na pangtrabaho gayundin ang guantes bago gamitin muli ang mga ito.

## Where Are Pesticides? Nasaan ang "Pesticides"?

### ■ Pesticides are applied in different ways:


- Liquids or sprays.
- Powders or granules.
- Gases.

Pesticides may be in many places. Pesticides may be on plants and on the soil. Often you can't tell pesticides are there.


### □ Ang ibat-ibang paraan ng pag-gamit ng "pesticides"



## How Can Pesticides Hurt You? Papaano Makasakit ang "Pesticides"?

### ■ Pesticides can hurt you if:


- They get on your skin.
- They get in your eyes.
- You breathe them.
- You swallow them.

Workers are hurt most often by getting pesticides on their skin.

### □ Makasakit ang "pesticides" kung:

- Malagyan ang balat.
- Malagyan ang mata.
- Malanghap.
- Malunuk.


■ Pesticides may cause skin rashes or hurt your nose, throat, or eyes.



■ Pesticides may harm some people more than others.

□ Ang "pesticides" ay maaring mas makasasakit sa ibang tao.

**■ Getting pesticides on or in you may have effects after months or years have passed.**

Delayed effects may be cancer, or harm to your kidneys, liver, or nervous system.

Another delayed effect may be birth defects, if pregnant women are exposed to pesticides.

**Maaring ilang buwan o taon bago makaramdam ng sakit dahil sa pagkakalantad sa "pesticides".**

Ang resulta ay maaring kanser o sakit sa bato, sakit sa atay o sakit sa "nervous system."

Ang isa pang resulta ay ang apekto sa sanggol na nasa sinapupunan, kung ang isang ina na nagdadalantao ay nalantad sa "pesticides".



## What If You Get Sick At Work? Ano ang Gagawin Kapag Nagkasakit sa Trabaho?



- Medical help is listed on or near a pesticide-safety poster at your work.

Make sure you know where this and the nearest phone are.

- Ang tulong sa paggagamot ay nakalista sa “pesticides safety poster” na nakapaskil sa trabaho.

Siguraduhing alam kung saan nakapaskil ito at ang pinakamalapit na telefono.

What if you get sick at work?  
Ano ang gagawin kapag nagkasakit sa trabaho?

■ If you or someone else gets sick while working, tell your boss right away.

Your boss must make sure you get to medical help if you think you've been poisoned at work by pesticides.


□ Sabihan kaagad ang iyong amo kahit sino man ang magkasakit sa trabaho.

Ang iyong amo ay kinakailangang tumawag ng tulong sa paggagamot kung sa palagay mong ikaw ay maaring nalason ng "pesticides".

- Your boss will provide information about the pesticide.

Your boss must give you or your doctor the name and other information about the pesticide that might have made you sick.


## What If Pesticides Get On Or In You? Ano Ang Dapat Gawin Kung Napuno Ang Katawan Ng "Pesticides"?

### ■ If a pesticide gets on you, get it off right away!

1. Take off clothing that has pesticide on it.
2. Rinse skin right away with water.
3. Wash with soap and water as soon as possible.

### □ Kung ang "pesticides" ay napalagay sa katawan o damit, alisin kaagad!


1. Alisin ang damit na napuno ng "pesticides".
2. Hugasan agad ng tubig ang balat.
3. Sabunin at hugasan ng tubig kaagad.

- **If you begin to feel sick or your eyes, skin, or throat hurt, go to a doctor right away.**

Your boss must make sure you are taken to a clinic or doctor.

- **Pumunta ka kaagad sa manggagamot, kun magkakaramdam o sasakit ang iyong mata, balat o lalamunan.**

Ang iyong amo ay kinakailangan maipadala ka sa klinika o sa manggagamot.


What if pesticides get on or in you?  
Ano ang dapat gawin kung napuno ang katawan ng "pesticides"?

■ If you or someone else swallows a pesticide, get medical help right away!

1. Call a poison control center or doctor, or go to the doctor if it's faster. Give the name of the pesticide and the first aid directions from the label.
2. If you can't call for help, or while you wait for help, follow the first aid steps on the label.
3. Get to a doctor as soon as possible! Have the name of the pesticide with you.



**What if pesticides get on or in you?**  
**Ano ang dapat gawin kung napuno ang katawan ng "pesticides"?**



□ **Tumawag kaagad ng tulong sa paggagamot, kung may nakalunok ng "pesticides"!**

1. Tumawag sa "poison control center" o sa manggagamot, o pumunta sa manggagamot, kung ito ang mas madaling paraan. Ibigay ang pangalan ng "pesticides" at sundin ang "first aid" na nasa eteketa.
2. Sundin ang mga hakbangin sa "first aid", kung hindi makakuha ng tulong o habang naghihintay ng tulong.
3. Sumundo kaagad ng manggagamot! Ihanda ang pangalan ng "pesticides".

What if pesticides get on or in you?  
Ano ang dapat gawin kung napuno ang katawan ng "pesticides"?

■ Leave closed areas right away if you start to feel sick or dizzy.

If you are working in an enclosed area, like a greenhouse, get to fresh air right away if you begin to feel dizzy or have trouble breathing.


□ Lumabas kaagad sa nababakurang kapaligiran, kung makaramdam ng sama ng katawan, pagkahilo o pangangapos ng paghinga.

Kung ikaw ay nagtrabaho sa isang kulon o saradong lugar katulad ng "greenhouse," lumabas kaagad sa may sariwang hangin sa sandaling makaramdam ng pagkahilo o pagsikip ng paghinga.

■ **If someone gets sick from breathing a pesticide...**

1. Get them to fresh air right away.
2. Loosen their clothing.
3. If not breathing, give mouth-to-mouth (CPR).

□ **Kung mayroong magkakasakit sa pagkalanghap ng "pesticides" ...**

1. Dalhin sila kaagad sa may sariwang hangin.
2. Luwagan ang kanilang pananamit.
3. Kung hindi humihinga ay bigyan ng "CPR".




■ If someone passes out in an enclosed area, get help—don't go in!

Never try to rescue someone who has passed out in a greenhouse or other enclosed area unless you have special training and breathing equipment. Find someone who can help.



□ Huwag pumasok sa nababakurang kapaligiran upang sumaklolo sa sinumang nawalan ng malay. Humingi ng tulong!

Huwag pilitin sumaklolo sa mga nawalan ng malay sa loob ng "greenhouse" o sa nababakurang kapaligiran, malibankung may "special training" at may kagamitan sa paghinga. Humanap ng ibang taong makakatulong sa pagsaklolo.

**■ Eye damage can happen fast!  
Rinse your eyes for 15 minutes.**

If a pesticide gets in your eyes, hold them open and rinse them with a gentle stream of cool water. Rinse for 15 minutes if possible. Then go to a doctor.

**□ Maaring masaktan kaagad ang mata! Hugasan ang mata sa loob nang 15 minuto.**

Kung ang "pesticides" ay mapalagay sa mata, hugasan kaagad sa madahang daloy ng malamig na tubig sa loob ng 15 minuto. Pumunta sa manggagamot.



## ■ Get medical help!


In all cases of pesticide poisoning, get medical help as soon as possible.

## □ Kumuha ng tulong sa paggagamot!

Kaagad humingi ng tulong sa panggagamot sa ano mang klase ng pagkakalason!



## The Law Helps Protect You! Ang Batas ay Tutulong sa Pangangalaga sa Sarili!



- Your boss must tell you about pesticide use at work.

Your boss must: Warn you about areas where pesticides are to be applied and areas you may not enter. Your boss must post: The name of the pesticide, exactly where it was applied, when it was applied, the restricted entry interval, and when the workers may return to the work area. This information has to be written and posted in a central location that is easily accessible to all workers, before the pesticides are applied.

- Kailangan kang pagsabihan ng iyong Amo tungkol sa paggamit ng “pesticides” sa trabaho.

Ang iyong Amo ay kinakailangang: Bigyan ka ng babala sa mga lugar ng pinagdidiligan ng “pesticides” at ng mga lugar na hindi dapat pusukan. Ang iyong Amo ay dapat maglagay ng babala na binabadya: ang pangalan ng “pesticides”; kung saan isinasabog ang “pesticides”; ang mga bawal pasukang lugar at kung kailan makababalik sa trabaho.


**■ Your boss must not let you work in some areas.**

Your boss must not let you work in an area where:

- Pesticides are being applied.
- Or pesticides may drift onto you.

After a pesticide is used, you may not enter a field during the Restricted Entry Interval (REI).

The laws set different safety periods or REIs for different pesticides.





■ You must have special training and protection for some jobs.

Without extra training and protection, your boss must not let you:

- Mix, load, apply, or handle pesticides.
- Work as a flagger.
- Work in an area where entry is restricted.

□ Kailangang mayroong kang “special training” at pangangalaga sa trabaho.


Kung walang kaalaman sa pagsasanay sa pangangalaga ay hindi ka dapat payagan ng iyong amo na:

- Maghalo, magsalin, mag lagay o mag buhat ng “pesticides”.
- Maging “flagger”
- Magtrabaho sa lugar na pinagbabawal ang pagpasok.

■ Your boss must not punish you for trying to follow these rules.

□ Hindi ka dapat kagalitan ng iyong amo sa pagsusumikap na sundin ang alituntunin sa “pesticides”.



## Help Protect Yourself! Tulungang Mapangalagaan ang Sarili!



### ■ Know how to protect yourself!

Your boss must protect you from pesticides, but your safety is your responsibility, too.

#### Alamin kung papaano mapapangalagaan ang sarili!

Kinakailangan kang pangalagaan ng iyong Amo sa "pesticides", subalit tungkulin mong pangalagaan ang iyong sarili.



Help protect yourself!  
Tulungang mapangalagaan ang sarili!

## ■ Remember:

- Wear clothes that cover your skin.
- Stay out of areas as instructed by your boss.
- Move away if pesticides drift into the area where you are working.
- Wash with soap and water after work and before eating, drinking, smoking, or using the toilet.

Your boss must:

- Give you information about pesticides applied in or near areas where you work.
- Be sure you are trained in pesticide safety.
- Provide you with soap, water, and towels.
- Make sure you get to medical help if you think you've been poisoned at work by pesticides.
- Provide you with extra training if you work in areas where entry is restricted, work as a flagger, mix, load, apply, or handle pesticides.



**Help protect yourself!**  
**Tulungang mapangalagaan ang sarili!**



### Tandaan:

- Magsuot ng damit na matatakpán ang balat.
- Lumayo sa mga lugar na binagbabawal ng iyong amo
- Umalis sa lugar na pinaggagawaan, kung aabot dito ang "pesticides" habang ito ay isinasabog.
