

- If the power cord or adaptor is damaged, replace the power supply cord and adapter. Call Customer Care for assistance.



### **Operation Instructions:**

- 1. Use this product only on a firm and level surface and prevent any objects or materials from covering the light source of the product.
- Connect the AC adapter input into the connector in the rear of the lamp. Plug the AC adapter into a standard household 120V AC outlet. Note: Use only with the supplied AC adapter to avoid damage or fire.
- 3. Touch On/Off  $\binom{1}{2}$  to turn on the lamp.
- 4. Touch control button 'to adjust brightness. There are five levels of brightness.
- 5. Touch (M) to switch between 3 light temperature modes: Warm, Natural, Bright light.
- 6. Touch ( ) to activate low level night light.
- 7. Touch ② once to activate Chroma RGB mood light. Touch ② once again to hold current color. Touch ③ to deactivate Chroma RGB mood light.
- 8. Touch On/Off (1) to turn off.


