

Intended Purpose and Audience

This guide describes how to perform common replacement activities for disks, power supplies and appliances. The audience includes both IBM Cloud Object Storage System  $^{\text{\tiny IM}}$  administrators and individuals responsible for hardware administration.

**Note:** This guide assumes that the appliances have already been installed. For instructions on installing, see the *Appliance Setup Guide* that was included in the box with the appliance. If the appliances have been installed and a more recent version of the software is available, the appliances should be upgraded to the newer version. Contact IBM for assistance with upgrades.

**Note:** For Cleversafe-branded Accesser 3105, Accesser 4105, Manager 3105, Slicestor 2212 and Slicestor 2448 appliances, see the respective *IBM Maintenance Manuals*. This manual applies to all other Cleversafe-branded appliances.

# Chapter 1. Manager disk replacement

### Overview

Regular maintenance procedures such as disk and appliance replacement differ between types (Manager, Accesser® Appliance, Slicestor® Appliance, or Fileserver pools). Disk replacement procedures for each one are described.

**Attention:** Disk replacement should be performed with a drive that is acquired by IBM. Using an alternative drive voids the support warranty and can potentially corrupt the data on the system.

All appliances contain an operating system disk. Slicestor® Appliance can have a separate operating system disk or the operating system that is stored on a partition of the first data disk.

**Note:** Appliance operating system disk failures incur appliance downtime. The requirements for replacing operating system disks are as follows.

- Recovery USB media to reinstall operating system.
- · Network access to the Manager application.
- At least as much capacity on the replacement disk as the failed disk.

See the Manager Device Monitor page on the Manager Web Interface for drive bay layout and status.

### Manager disk backup

Before you replace Manager disks, back up the data. Regular automatic backups should be scheduled. Follow the procedures in the "Backup and restore Manager" section of the *IBM Manager Administration Guide*.

# Replace RAID disks

# Replacing one RAID disk About this task

The appliance can remain powered on when you replace a single disk.

#### **Procedure**

- 1. Acquire a replacement disk by contacting customer solutions.
- 2. Click the **Manager** device link. A warning message is displayed: The manager device RAID disk is operating in degraded mode.
- 3. Click Configure.
- 4. Make a note of the bay number that is listed as ONLINE, and replace the drive that is not listed. The drive that is listed is the good drive.

**Note:** Event console displays a message similar to - The drive in bay 0 has caused an array to be degraded. The bay number of the bad drive can be taken from that event, too.

5. Replace the failed disk. Replacement disk rebuilds, stating **Repairing local drive array**. When the new drive is attached, the event console displays messages, such as: The drive in bay 0 was attached. The local drive in bay 0 is repairing.

Disk repair is complete when the Event Console displays the message **Local drive array has been repaired**.

### Replacing two RAID disks

### **Procedure**

If a total RAID array failure occurs, contact IBM Customer Support.

### Replacing a Manager 3100 operating system disk

#### About this task

Manager 3100 has three disks: a dedicated operating system disk and two data disks that are configured as a RAID-1 array.

#### **Procedure**

- 1. Acquire replacement disk by contacting IBM Customer Support.
- 2. Turn off the appliance.
- 3. Replace operating system disk.
- 4. Insert USB installation media and power the appliance on.
- 5. Press the appropriate function key during the startup to enter the boot select menu.
- 6. Select the **USB media** from which to boot, when the boot select menu appears.
- 7. Wait for the Installation page to display.
- 8. Follow the next prompts and select **Automated** > **OS drive install** when presented. The image is installed on the replaced operating system drive and the device reboots.
- 9. Reconfigure the network parameters: channel port, IP, gateway, netmask, Manager IP, and system parameters. Manager should be reconfigured with the same IP as the previous device. Refer to *IBM Appliance Configuration Guide* for the procedure to configure a Manager device.

Note: You do not need to restore from a system backup.

# Chapter 2. Accesser and Slicestor appliance disk replacement

### Replacing an Accesser appliance operating system disk with SW Raid

#### About this task

Upon disk failure, obtain a replacement disk by contacting IBM Customer Support.

#### **Procedure**

- 1. For this procedure, you do not need to turn the appliance off.
- 2. For an SW RAID, a single failed-drive no longer requires a full re-install of the OS. The bad drive can now be swapped out, and then the system automatically recovers the raid array while syncing up the new drive.
- 3. Replace disk.

### Replacing an Accesser appliance operating system disk

### **About this task**

Upon disk failure, obtain a replacement disk by contacting IBM Customer Support.

### **Procedure**

- 1. Turn off the appliance.
- 2. Replace disk.
- 3. Insert USB installation media and power on the appliance.
- 4. Press the appropriate function key during the startup to enter the boot select menu.
- 5. Reconfigure the system network parameters channel port, IP, gateway, netmask; manager IP and system parameters. See the *IBM Appliance Configuration Guide* for the procedure to configure an Accesser® Appliance.
- 6. Select the **USB media** from which to boot, when the boot select menu appears. Wait for the installation screen to appear.
- 7. Follow the next prompts and select **Automated** > **OS drive install** when presented.
- 8. Wait for installation to complete and the appliance to reboot, then remove the USB media.
- 9. Reconfigure the system network parameters: channel port, IP, gateway, netmask, Manager IP, and system parameters. See *IBM Appliance Configuration Guide* for the procedure to configure an Accesser appliance.
- 10. Make a note of its fingerprint after the configuration for a device is complete. Run **system fingerprint** to verify this information when approving devices in the Manager.
- 11. Consult the *Appliance Configuration Guide* for further instructions, if the disk is part of a High Availability configuration.

The Accesser appliance is now ready for use.

**Note:** Statistics data and Access logs are retained after an OS disk replacement if **Management Vault** was enabled on the Manager. Refer to "Management vaults" in *IBM Manager Administration Guide*.

## Replacing a Slicestor appliance operating system disk with SW Raid

#### About this task

Upon disk failure on a Slicestor appliance, obtain a replacement disk by contacting IBM Customer Support.

### **Procedure**

- 1. For this procedure, you do not need to turn the appliance off.
- 2. For an SW RAID, a single failed-drive no longer requires a full re-install of the OS. The bad drive can now be swapped out, and then the system automatically recovers the raid array while syncing up the new drive.
- 3. Replace disk.

### Replacing a Slicestor appliance operating system disk

#### About this task

Upon disk failure on a Slicestor appliance, obtain a replacement disk by contacting IBM Customer Support.

- 1. Turn off the appliance.
- 2. Replace the operating system disk (see table for drive locations).

- 4. Turn on the appliance and press the F11 key during the startup to enter the boot select menu.
- 5. Select the **USB media** to boot from, when the boot select menu appears.
- 6. Follow the next prompts and select **Automated** > **OS drive install** when presented.
- 7. Press the **Enter** key.
- 8. Wait for installation to complete and the appliance to reboot.
- 9. Remove the USB installation media after the reboot completes and the BIOS splash screen appears.
- 10. Reconfigure the network parameters: channel port, IP, gateway, netmask, manager IP, and system parameters. See the *IBM Appliance Configuration Guide* for the procedure to configure a Slicestor<sup>®</sup> Device
- 11. After the configuration for a device is complete, make a note of its fingerprint. Run system fingerprint to verify this information when approving devices in the Manager. The Slicestor<sup>®</sup> Appliance is ready to use.

Note: Statistics data will be retained after an OS disk replacement if Management Vault was enabled on the Manager. See the section, "Management vaults" in the Manager Administration Guide.

### Replacing a data disk

### **About this task**

Upon data disk failure on an appliance, obtain a replacement disk by contacting IBM Customer Support.

- 1. For all Slicestor appliances, consult the Manager Web Interface for disk location and insert a new disk.




Figure 2. Slicestor 1440 and 2440 - Layout

- 4. Pinch the clip at the end of the power supply at the rear of the system and slide the power cable out.
- 5. Insert the new power supply until it clicks into place.
- 6. Reconnect the power supply unit's power cable.
- 7. Contact your Customer Success Engineer to verify that the system is functioning correctly.

### Replacing a Slicestor 2210 power supply unit

Replacing a power supply unit in a Slicestor 2210 system.

### About this task

Do the following procedure to replace a power supply unit in the Slicestor 2210 system. The power supply is hot pluggable; therefore, the system does not need to be powered down.

### **Procedure**

1. Identify the power supply unit (PSU) that needs to be replaced.




Figure 3. Slicestor 2210 - Layout

- 2. Disconnect the power supply unit's power cable.
- 3. Pinch the clip at the end of the power supply at the rear of the system and slide the power cable out.
- 4. Insert the new power supply until it clicks into place.

- 6. Contact your Customer Success Engineer to verify that the system is functioning correctly.

# Chapter 4. Optical module replacement

# Installing an SFP+ optical module

- 1. Log in to the device as **localadmin**.
- 2. Enter **poweroff** at the command line.
- 3. Remove the SFP+ module from the packaging.
- 4. Remove the black plastic cap from the optical side of the module.
- 5. Insert the module into the network card until it clicks into place.
- 6. Insert the fiber optic cable into the SFP+ module.
- 7. Restart the system and configure the network interface (see *Appliance Configuration Guide*).

# **Chapter 5. Fan replacement**

### Accesser 2100, Accesser 3100, and Manager 3100 fans

For the procedures to replace fans see the respective Appliance Maintenance Manuals.

### Slicestor 1440/2440 fans

The system has six fans. Three fans are at the front of the system and three fans are in the middle of the system.




Figure 4. Slicestor 1440/2440 - fan locations

# Replacing a front fan

Replacing the front fans in the IBM Slicestor 1440 and 2440 systems.

### Before you begin

Note: This procedure can be done by one person.

**Note:** The system must be shut down before any cables are disconnected and any maintenance is done. If the system is not shut down, the lights on the power supply units are green. When the system is shut down, the lights on the power supply units are orange.

- 1. Contact the STG assigned contact so that the system can be shut down before cables are disconnected. When the system is shut down, the lights on the power supply units are orange.
- 2. Remove the two screws that are located below the handles on each side of the front of the system. The screws secure the system to the rack.




Figure 5. Slicestor 1440/2440 - front panel

- 3. Disconnect the power cables and the network cables. When the power cables are disconnected, the lights on the power supply units are off.
- 4. Pull the system from the front, or push from the rear, so that the system is halfway out of the rack.
- 5. Remove the four screws from the front lid. The top panel has two lids.




Figure 6. Slicestor 1440/2440 - top panel

- 6. Remove the front lid.
- 7. Identify the fan that needs to be replaced by using either the Figure 4 on page 13diagram or the diagram on the underside of the front lid.
- 8. Cut away the cable ties, making sure not to cut any of the fan power cables.
- 9. Remove the faulty fan by lifting it up, while pushing down the catch on top.
- 10. Remove the fan's power cable carefully.
- 11. Insert the new fan and connect the power cable to the power connector on the far left.
- 12. Dress the cables so that the lid will sit flat when replaced.
- 13. Replace the lid and reinsert the four lid screws.
- 14. Push the system back into the rack. Reconnect the network cables and then reconnect the power cables.
- 15. Insert the two screws under the handles on the front panel.
- 16. Contact STG to verify with that the system is back up and functioning. Booting up the system up might take ten minutes to complete.

# Replacing a middle fan

Replacing the middle fans in the IBM Slicestor 1440 and 2440 systems.

### Before you begin

Note: This procedure must be done by two people, due to the weight of the system. The system must be removed from the rack.

**Note:** The system must be shut down before any cables are disconnected and any maintenance is done. If the system is not shut down, the lights on the power supply units are green. When the system is shut down, the lights on the power supply units are orange.

- 1. Contact the STG assigned contact so that the system can be powered down before cables are disconnected. When the system is shut down, the lights on the power supply units are orange.
- 2. Remove the two screws that are located below the handles on each side of the front of the system. The screws secure the system to the rack.




Figure 7. Slicestor 1440/2440 - front panel

- 3. Disconnect the power cables and the network cables. When the power cables are disconnected, the lights on the power supply units are off.
- 4. Slide the system out of the rack by pressing the left and right levers to release the system from the rail kit. Two people are needed to lift the system to the floor.
- 5. When the system is on the floor or a flat surface, remove the front and rear lids, by removing the four screws from each lid.




Figure 8. Slicestor 1440/2440 - top panel

- 6. Identify the fan that needs to be replaced by using either the Figure 4 on page 13diagram or the diagram on the underside of the front lid.
- 7. Locate the fan's power cable on the system board and disconnect it.
- 8. Release the clip, holding the fan down, and pull upwards carefully removing the fan's power cable.
- 9. Thread the new fan's power cable and insert the fan firmly into the chassis. Connect to the Fan's power cable to the system board connector.
- 10. Replace the rear lid and then the front lid by using the lid screws.
- 11. Place the Slicestor back into the rail kit and slide it into the rack.
- 12. Secure the system with the two front rack screws that were removed earlier.
- 13. Reconnect the network cables first then the power cables.
- 14. Contact STG to verify with that the system is back up and functioning. Booting up the system up might take ten minutes to complete.

### Slicestor 2210 fans

### Replacing a fan

Slicestor 2210 fan replacement

#### About this task

The fans are different in the 2210 and the 2212. Make sure that the correct part is being fitted.

- 1. Contact the STG assigned contact so that the system can be shut down before cables are disconnected. When the system is shut down, the lights on the power supply units are orange.
- 2. Remove the power cables and network cables.
- 3. Slide the system out of the rack completely and place on a stable surface.
- 4. Remove the two small screws (1) on the left and right of the system.




Figure 9. Slicestor 2210 - top panel

- 5. Press the two finger tabs (2) on the top panel and slide the top panel back (3). Then lift the top panel (4).
- 6. Identify the failed fan.
- 7. Remove the fan by pinching the Release Tab at the top of the fan and removing it.




Figure 10. Slicestor 2210 - fan release tab

**8**. Replace the Fan by pushing it in until the tab secures.




Figure 11. Slicestor 2210 - fan replacement

- **9**. Replace the top panel and replace the screws.
- 10. Slide the system back into the rack. Reconnect the network cables and then reconnect the power cables.
- 11. Contact STG to verify that the system is back up and functioning Booting up the system up might take ten minutes to complete.
