Before you install the Maximo® Asset Health Insights 7.6.0.1 feature pack, ensure that the enterprise environment is up-to-date. You install the feature pack for Maximo Asset Health Insights 7.6.0.1 by following the instructions that are in download document on IBM Fix Central.

Maximo Asset Management version 7.6.0.6 and Maximo Asset Health Insights version 7.6.0 must be installed.

If your environment is not up-to-date, take the action in the following table:
