



Figure 1. Forward Current vs. Ambient Temperature






Figure 3. Rel. Luminous Intensity vs. Angular Displacement





Figure 4. Relative Intensity vs. Wavelength






Figure 6. Relative Luminous Intensity vs. Forward Current




Figure 7. Rel. Luminous Intensity vs. Ambient Temperature






Figure 8. Forward Voltage vs. Ambient Temperature









METHOD OF TAPING/POLARITY AND TAPE AND REEL

SMD LED (VLM3 - SERIES)

Vishay's LEDs in SMD packages are available in an antistatic 8 mm blister tape (in accordance with DIN IEC 40 (CO) 564) for automatic component insertation. The blister tape is a plastic strip with impressed component cavaties, covered by a top tape.

REEL PACKAGE DIMENSION IN MM FOR SMD LEDS, TAPE OPTION GS18 (= 8000 PCS.) PREFERED




Figure 11. Reel dimensions - GS18




Figure 9. Tape dimensions in mm for PLCC-2



SOLDERING PROFILE




Figure 12. Vishay Leadfree Reflow Soldering Profile (acc. to J-STD-020C)





Figure 13. Double wave soldering of opto devices (all packages)



DRY PACKING

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



FINAL PACKING

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

RECOMMENDED METHOD OF STORAGE

Dry box storage is recommended as soon as the aluminium bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity \leq 60 % RH max.

After more than 672 hours under these conditions moisture content will be too high for reflow soldering.


In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 hours at 40 °C + 5 °C/ - 0 °C and < 5 % RH (dry air/nitrogen) or

96 hours at 60 $^{\circ}\text{C}$ + 5 $^{\circ}\text{C}$ and < 5 % RH for all device containers or

24 hours at 100 $^\circ\text{C}$ + 5 $^\circ\text{C}$ not suitable for reel or tubes.

An EIA JEDEC Standard JESD22-A112 Level 2a label is included on all dry bags.

Proper storage and handling procedures should be followed to prevent ESD damage to the devices especially when they are removed from the Antistatic Shielding Bag. Electro-Static Sensitive Devices warning labels are on the packaging.
