



 - (1) Attach the alignment sticker to the surface.
 - (2) Drill one hole for cable at the center.
 - (3) Drill two pilot holes (Ø7mm×40mm(D)) through the two circles on the sticker.



4-2 Adjusting the view angle

(1) The lens pan direction can be adjusted by rotating the dome cover by hand. Note:

- Do not rotate the dome over 350°, otherwise the inner connector may break. damaging the camera.
- (2) Tilt angle of the lens can be adjusted within the limit of 0° to +75° by rotating "Tilt ADJ screw" with a compatible screw driver.


