

## ■ The names and functions of each part



# 1 [REC] button and [REC] Indicator (Red)

[REC] button is used to make setting of recording standby and putting a mark.

Indicator turns red during recording and blinks during recording standby.

Locater buttons

#### @[STOP] button

Stop operation of recording and playback.

#### @ [PLAY/PAUSE] button

Make operation of recording and playback, also use for a temporary stop and re-start operation.

# 4 [REW] button Make selections of

Make selections of rewinding and files.

# 6 [FF] button

Make selections of fast forwarding and files.

#### @RECLEVEL [+/-]

Adjust recording level.

# VOLUME [+/-]

Adjust recording level.

# (3) INPUT [MIC] [1] [2] buttons and INPUT Indicator (Green, Yellow, Red)

Make selections of input source.

The indicator of the selected input button turns green light on.

#### Remote controller jack

Plug the jack in to the remote controller's jack.

#### ■ SAFETY PRECAUTION / Usage precaution

The RC4 is a precision instrument. Do not exert undue pressure on the switches and other controls. Also take care not to drop the unit, and do not subject it to shock or excessive pressure.

Please do not pull the cable and the lack strongly.

- Extremely hot or cold temperature
- Close to a heater, oven, radiator (heat source)
- Very high humidity, closer to shower or steam (covered with drops)
- Sandy or dusty

Use a soft, dry cloth to clean the RC4. If necessary, slightly moisten the cloth. Do not use abrasive cleanser, wax, or solvents (such as paint thinner of cleaning alcohol).
