

What are the features of my iMac?

Your computer has these built-in capabilities:



W Modem

Connect to the Internet, browse the World Wide Web, and send and receive electronic mail.

FireWire

(on some models) Connect high-speed devices such as digital video cameras, disk drives, printers, and scanners.

Record sounds using an analog microphone or other audio device.

Sound output

Connect headphones, external speakers, and analog audio devices.

◀ Reset button

Use during troubleshooting to restart your computer.



Connect printers, disk drives, digital cameras, digital speakers, joysticks, and more.

♦♦ Ethernet

Share files with another computer and access a computer network, printer, or the Internet.

VGA output



Install additional memory and an AirPort Card for wireless networking.




What are the basics?

Application


Applications are software programs (such as a game or word processor) that you use with your computer. Double-click an application's icon to open the application.

Document


Documents are files that you create with an application (such as a letter you create with your word processor). Double-click a document's icon to open the file and to view, edit, or print it.

Use Sherlock 2 to quickly search the Internet.





What about software?







To install software that's on a CD:



- Insert the disc in the drive slot with the label facing up, then double-click the disc's icon to open it.
 - CD-ROM discs can be used in DVD-ROM drives.
 - ▶ Use only circular discs with your CD or DVD drive. Apple does not recommend the use of non-circular discs.
- Double-click the installation application to install the new software on your computer.
- When you're ready to eject the disc, drag the disc's icon to the Trash.

If your computer has FireWire:

You can create your own movies using iMovie and a digital camcorder.

Full screen button





Before installing:


- shut down the computer
- unplug all cables, except the power cord
- place the computer face down on a soft cloth




Open the access door using a coin to turn the latch.




- Touch the metal shield inside the recessed latch area. Then unplug the power cord.
 - ► Touch this metal before you touch any parts inside the computer. Don't walk around the room until you've finished installing memory or an AirPort Card.



- To install memory, insert a memory module into one of the two lower slots.
 - ▶ Be sure to align the notches on the module with the small notches inside the slot.



To install an AirPort Card, detach the antenna from the guide rail, then remove the protective plastic cap.



Then connect the antenna to the AirPort Card and insert the card sideways into the slot.

▶ For instructions on using the AirPort software, look in Mac Help, available in the Help menu.




Close the access door and use a coin to close the latch.


Never turn your computer on unless all of its internal and extra parts are in place.

- Open the Help menu and choose Mac Help.
- Type a question or keywords, then click Search.
 - You can also browse through information about your computer by clicking one of the blue underlined items in the window.
 - To view Help for other applications, choose Help Center from the Help menu.



What if I have a problem?

If the computer won't respond or the pointer won't move:

First, make sure the mouse and keyboard are connected.

 Unplug and then plug in the connectors and make sure they are firmly seated.

Then try to cancel what the computer is doing.

- Press the Command (黑) and period (.) keys at the same time. If a dialog box appears, click Cancel.
- If that doesn't work, hold down the Option and Command (寒) keys, then press the Esc key. If a dialog box appears, click Force Quit. If you return to the Finder (the Finder is checked in the Application menu; see page 4), restart your computer.

If the computer still doesn't respond, restart it.

- Press the Power button on the computer.
- If that doesn't work, hold down the Control and Command (寒) keys, and then press the Power button on the computer.
- If that doesn't work, press the Reset button (see page 3).
- If that doesn't work, hold down the Power button on the computer for 5 seconds. After your computer turns off, press the Power button on the computer to turn it on again.
- If that doesn't work, unplug the power cord from the computer.
 Then plug the power cord back in and press the Power button on the computer to turn it on.

Then do this:

If the problem occurs frequently when you use a particular application:

 Check with the application's manufacturer to verify that it is compatible with your computer and the version of system software your computer is using.

If the problem occurs frequently:

 Choose Finder in the Application menu (see page 4). Then open the Help menu and choose Mac Help. Look at the section on how to prevent and solve problems. You may need to check for extension conflicts or reinstall your computer's system software.

If the computer "freezes" during startup or you see a flashing question mark:

Turn off system extensions.

Start up your computer while holding down the Shift key.

If that does not work, start up using the software install CD.

 Insert the software install CD that came with your computer and start up while holding down the C key. (Make sure the Caps Lock key is not engaged.)

Then do this:

After the computer starts up:

- Make sure that the hard disk that contains the System Folder is selected, or highlighted, in the Startup Disk control panel.
- Then open the Help menu and choose Mac Help. Look at the section on how to prevent and solve problems. You may need to check for extension conflicts or reinstall your computer's system software.

If you notice that the background picture is different:

 You probably started up your computer using the system software on a CD instead of your hard disk. If this is the only way that you startup your computer, you should reinstall the system software on your hard disk. Look for instructions in Mac Help or use the Installer application on your software install CD.

If the computer won't turn on or start up:

First, make sure the power cord is connected.

- The plug on the power cord must be completely inserted into the computer's power socket and firmly seated for your computer to operate correctly. Make sure the power cord is plugged into a working electrical outlet.
- If your computer is plugged into a power strip, make sure the power strip is turned on.

If that does not work, reset your computer.

■ Start up the computer and immediately hold down the Command (無), Option, P, and R keys until you hear the startup sound a second time. Then release the keys.

If that does not work or if you hear musical tones during startup:

- You may have a problem with RAM (random-access memory). If you recently installed additional memory, make sure that it is correctly installed and that it is compatible with your computer.
- See the service and support information that came with your iMac for information on having your computer serviced.

Other problems

If you have a problem with your dial-up Internet connection:

- Make sure the telephone line is properly connected to your computer and the line is functioning properly.
- Wait a while, then try connecting again.
- Choose Finder in the Application menu (see page 4). Then open the Help menu and choose Mac Help. There you can find your Internet settings and the contact information for your Internet service provider.

If you have a problem with a software program:

 To resolve problems with software, contact the software manufacturer.

If you have a problem using your computer:

- Look at the information in Mac Help for instructions and troubleshooting information.
- Go to the Apple Support Web site on the Internet (www.apple.com/support) for the latest troubleshooting information and software updates.

How do I work comfortably?

The guidelines in this section can help you work more comfortably with your computer. For detailed information about ergonomics, see Apple's Environmental Health and Safety Web site at: www.apple.com/about/ergonomics

Keyboard

- When you use the computer keyboard, your shoulders should be relaxed. Your upper arm and forearm should form an approximate right angle, with your wrist and hand in roughly a straight line.
- You may have to raise your chair so your forearms and hands are at the proper angle to the keyboard. If this makes it impossible to rest your feet flat on the floor, you can use a footrest with adjustable height and tilt to make up for any gap between the floor and your feet. Or you may lower the desktop to eliminate the need for a footrest. Another option is to use a desk with a keyboard tray that is lower than the regular work surface.
- Use a light touch when typing and keep your hands and fingers relaxed. Avoid rolling your thumbs under your palms.

Mouse

 Position the mouse at the same height as your keyboard. Allow adequate space to use the mouse comfortably.


Chair

- An adjustable chair that provides firm, comfortable support is best.
 Adjust the height of the chair so your thighs are horizontal and your feet flat on the floor.
- The back of the chair should support your lower back (lumbar region). Follow the manufacturer's instructions for adjusting the backrest to fit your body properly.

Computer

- Arrange the computer so the top of the screen is slightly below your eye level when you're sitting at the keyboard. The best distance from your eyes to the screen is up to you, although most people seem to prefer 18 to 28 inches (45 to 70 cm).
- Position the computer to minimize glare and reflections on the screen from overhead lights and windows.

Important Don't lift the computer using the flip-out foot. You could damage your computer. To move your computer, grab the handle on the top of the computer with one hand; with your other hand, hold the bottom of the computer.



Avoiding fatigue

- Change your seated position, stand up, or stretch whenever you start to feel tired. Frequent short breaks are helpful in reducing fatigue.
- Use a light touch when typing or using a mouse and keep your hands and fingers relaxed.
- Some computer users may develop discomfort in their hands, wrists, or arms after periods of intensive work without breaks.
 If you begin to develop chronic pain or discomfort in your hands, wrists, or arms, consult a qualified health specialist immediately.
- Allow adequate workspace so that you can use your keyboard and mouse comfortably. Place papers or other items so you can view them easily while using your computer. A document stand may make reading papers more comfortable.
- Eye muscles must work harder to focus on nearby objects.
 Occasionally focus your eyes on a distant object, and blink often while you work.
- Clean your screen regularly. Keeping the screen clean helps reduce unwanted reflections (see page 27).

Is there anything else I need to know?

Follow these instructions for using your iMac safely and wisely.

Safety

Make sure that you

- keep these instructions handy for reference by you and others who may use your computer
- follow all instructions and warnings regarding your system

When setting up and using your computer, remember the following:

- Place your computer in a location with adequate ventilation. Never block the vents on the computer.
- Your computer has a three-wire grounding plug that will only fit a
 grounded AC outlet. If you are unable to insert the plug into the
 outlet, contact a licensed electrician to replace the outlet with a
 properly grounded outlet.
- Make sure you only connect the modem to an analog phone line, the type commonly used in residences. Do not connect a digital telephone line to the modem, because it could damage the modem.
- Never turn on your computer unless all of its internal and external parts are in place. Operating the computer when it is open or missing parts can be dangerous and damage your computer.

Important The only way to disconnect power completely is to unplug the power cord. Make sure at least one end of the power cord is within easy reach so that you can unplug the computer when you need to.

Warning Electrical equipment may be hazardous if misused. Operation of this product must always be supervised by an adult. Do not allow children access to the interior of this product and do not permit them to handle any cables.

For your own safety and that of your equipment, always disconnect the power plug (by pulling the plug, not the cord) if any of the following conditions exists:

- you want to remove any parts (leave the cord disconnected as long as the computer is open)
- the power cord or plug becomes frayed or otherwise damaged
- you spill something into the case
- your computer is exposed to rain or any other excess moisture
- your computer has been dropped or the case has been otherwise damaged
- you suspect that your computer needs service or repair
- you want to clean the case (use only the recommended procedure discussed in Mac Help)

Be sure that you always do the following:

- Keep your computer away from sources of liquids, such as drinks, washbasins, bathtubs, shower stalls, and so on.
- Protect your computer from dampness or wet weather, such as rain, snow, and so on.

Cleaning your computer equipment

To clean your computer equipment, use only the recommended procedures discussed in Mac Help.

Warning Do not clean the screen with a cleaner that contains alcohol or acetone. Never spray cleaner directly onto the screen. Liquid could drip inside the screen and cause an electrical shock.

Power supply

The power supply in your computer is a high-voltage component and not user-serviceable. If you suspect the power supply needs service, contact your Apple-authorized dealer or service provider.

Warning Do not attempt to access the high-voltage area or power supply. If you suspect the power supply needs service, contact your Apple-authorized dealer or service provider.

Power-saving and environmental features

Your display is equipped with energy-saving features that allow the display to conserve energy when the computer is not in use. For instructions on adjusting the system and display sleep settings and additional energy-conservation information, see Mac Help.

Telephone and modem information

Some telephone companies require that you notify the local business office when you hook up a modem to their lines.

Information you need in the United States

The internal modem complies with Part 68 of the FCC rules. On the back of this equipment is a label that contains, among other information, the FCC registration number and ringer equivalence number (REN). If requested, provide this information to your telephone company.

- Ringer equivalence number (REN): 0.8—0.9 The REN is useful to determine the quantity of devices you may connect to your telephone lines and still have all those devices ring when your telephone number is called. In most, but not all areas, the sum of the RENs of all devices connected to one line should not exceed five (5.0). To be certain of the number of devices you may connect to your line, as determined by the REN, you should contact your local telephone company to determine the maximum REN for your calling area.
- Telephone jack type: USOC, RJ-11 An FCC-compliant telephone cord and modular plug are provided with this equipment. This equipment is designed to be connected to the telephone network or premises wiring using a compatible modular jack that complies with Part 68 rules. See the installation instructions for details.

Telephone line problems

If your telephone doesn't work, there may be a problem with your telephone line. Disconnect the modem to see if the problem goes away. If it doesn't, report the problem either to your local telephone company or to your company's telecommunications people.

If disconnecting the modem eliminates the problem, the modem itself may need service. See the service and support information that came with your Apple product for instructions on how to contact Apple or an Apple-authorized service provider for assistance.

If you do not disconnect your modem when it is adversely affecting the telephone line, the telephone company has the right to disconnect your service temporarily until you correct the problem. The telephone company will notify you as soon as possible. Also, you will be informed of your right to file a complaint with the FCC.

The telephone company may make changes in its facilities, equipment, operations, or procedures that could affect the operation of your equipment. If this happens, the telephone company will provide advance notice in order for you to make the necessary modifications to maintain uninterrupted service.

The optional internal modem will not work with party lines, cannot be connected to a coin-operated telephone, and may not work with a private branch exchange (PBX).

Telephone Consumer Protection Act

The Telephone Consumer Protection Act of 1991 makes it unlawful for any person to use a computer or other electronic device to send any message via a telephone fax machine unless such message clearly contains in a margin at the top or bottom of each transmitted page or on the first page of the transmission, the date and time it was sent and an identification of the business or other entity, or individual sending the message and the telephone number of the sending machine of such business, entity, or individual.

Information you need in Canada

The Industry Canada (IC) label identifies certified equipment. This certification means that the equipment meets certain telecommunications network protective, operational, and safety requirements. The Department does not guarantee the equipment will operate to a user's satisfaction.

Before installing this equipment, make sure that you are permitted to connect to the facilities of the local telecommunications company. Be sure you use an acceptable method of connection to install the equipment. - AT&G0 (no guard tone)
- AT&P1 (33/66 pulse dial make/break ratio)
- ATS0 = 0 or ATS0 = 1 (no answer or answer greater than one ring)
- ATS6 = 95 (DTMF period between 70-255 ms)
- ATS11 = 95 (DTMF period between 70–255 ms)

For calls that are automatically generated, a total of three call attempts are allowed to a telephone number, with a minimum period between calls of 2 seconds. If the call does not connect after three attempts, 30 minutes must expire before automatic redialing may be initiated. Failure to set the modem (and any associated communications software) to the above settings may result in the modem being non-compliant with Australian telecommunications standards. Under these circumstances a user could be subject to significant penalties under the Telecommunications Act 1997.

This modem must be properly secured in order for you to use it. Telecommunications network voltages exist inside the computer and the telecommunications line connection must be removed before opening the computer.

Information you need in New Zealand

This modem is fully approved to operate on the New Zealand telecommunications network under Telepermit number PTC 211/98/119. All telecommunications devices are required to hold a Telepermit and be labelled accordingly with the approved Telepermit number to comply with the New Zealand telecommunications standards, ensuring the health and safety of the operator and the integrity of the New Zealand telecommunications network.

Customers in New Zealand who are prompted to choose a country for their modem should choose the "Australia" country code setting.

To ensure compliance, all calls that are automatically generated should not make more than 10 call attempts to the same number within any 30 minute period with a minimum period between calls of 30 seconds. Failure to adhere to these standards may result in the modem being non-compliant with New Zealand Telecom standards. Under these circumstances a user could be subject to significant penalties.

If pulse dialing is required for any reason, the communications software must be set up to record numbers according to the following translation list.

- Number to be dialed: 3; number to be entered into computer: 7

- Number to be dialed: 6; number to be entered into computer: 4
- Number to be dialed: 7; number to be entered into computer: 3
- Number to be dialed: 8; number to be entered into computer: 2
- Number to be dialed: 9; number to be entered into computer: 1
- Number to be dialed: 0; number to be entered into computer: 0

The preferred method of dialing is to use DTMF tones as this is faster than pulse (decadic) dialing and is readily available on almost all New Zealand telephone exchanges.
