



PACIFIC Cutter Type Trimmer

Hand or Power

OPERATING INSTRUCTIONS

Case trimming is necessary for those who desire the utmost in shooting accuracy. It affords an even, uniform case needed for proper bullet seating.

1. A. For trimming pistol cases insert the #1 Die of the Three Die Pistol Set into the Pacific Super Deluxe Tool.
B. For trimming rifle cases, you will have to use the proper die body (9-Y20) for the rifle case you will be trimming.
2. Bring the shell holder to the top of stroke and adjust the die down against it. Lock into place with $\frac{7}{8}$ -14 lock Ring.
3. Place shell to be trimmed into proper shell holder and bring the shell holder to the top of stroke.
4. A. To use as hand type, place cutter knob (9-Y15) on cutter (9-Y11) and tighten screw. To operate, turn handle (9-Y15) clockwise with downward pressure.
B. To use as power trimmer, place cutter arbor (9-Y16) into cutter (9-Y11) and tighten lock nut (9-D11). Place arbor into $\frac{1}{4}$ " hand drill. To operate, start drill and apply pressure in a downward position.

NOTE: A small amount of Pacific Die Lubricant placed on cutter will improve operation.

5. Place the cutter assembly into the Die body and adjust to depth you wish by using adjustable stop nut (9-Y13) and tighten set screw (9-Y14).
6. Upon removal of the trimmed shell case from the shell holder, chamfer and deburr the case by using Pacific's chamfering and deburring tool. Instructions for use are outlined below.

Place chamfering end of tool into case mouth and rotate once or twice to remove sharp edge. Reverse ends of tool and place deburring end over mouth of case. Rotate as before.
