#### HOLD (Function lock)


The hold function stops the buttons from being operated. By keeping the hold function on, you can stop the power from being switched on, play from being stopped and other operations from being done by mistake.

#### Resume function

Play resumes from where last stopped. [The resume function is canceled if you open the lid while stopped (while the power is ON). The resume function is also canceled when the disc is changed.]

- If the batteries are depleted, removed, or the unit is subjected to strong shock, all settings are canceled including resume function.

## Troubleshooting guide

Before requesting service, make the following checks. If you are in doubt about some of the check points, or if the solutions indicated in the chart do not solve the problem, refer to the "Customer Services Directory" on page 3 if you reside in the U.S.A., or refer to the "Product information" on page 4 if you reside in Canada.

<b>No play.</b>	<ul style="list-style-type: none"> <li>• HOLD is on, stopping buttons from being operated. Cancel HOLD (⇨ page 5).</li> <li>• The batteries may be drained (⇨ page 5).</li> <li>• The disc isn't correctly set.</li> <li>• The disc is scratched or dirty. (Tracks may be skipped particularly with MP3 discs.)</li> <li>• There is moisture on the lens. Wait for about an hour and then try again.</li> <li>• The lens is dirty: clean it with a blower (recommended product: SZZP1038C). You cannot use a CD type lens cleaner. If the lens gets marked with fingerprints, gently wipe them off with a cotton swab.</li> <li>• Remove the plug and reinsert it as fully as possible.</li> <li>• The unit may not read a track properly if shaken strongly during disc reading.</li> <li>• If there is no data between sessions on a multi-session disc, play may not be possible.</li> <li>• If there is a large amount of JPEG data etc. within a MP3 file, sound may be muted and play may not be possible.</li> <li>• If the disc contains data with different formats, sound may be muted and play may not be possible.</li> <li>• If a CD-ROM format disc contains MP3 and other files, only the MP3 files will be playable.</li> </ul>

<b>Cannot search through tracks.</b>	You cannot search through a disc with MP3 files.
<b>Cannot specify point A or B.</b>	You may not be able to specify point A or B at the end of a disc.
<b>Cannot change the Digital Re-master mode, anti-skip mode.</b>	If [◀◀] or [▶▶] is pressed before [MEMO] you cannot change the mode.
<b>Digital Re-master does not work.</b>	Depending on the type of MP3 disc recording, the effect may not appear.
<b>Cannot skip albums.</b>	You cannot skip from the last to first album, or vice versa, during play.
<b>The battery indicator fails to appear or is incorrect.</b>	The indicator may not appear correctly under certain conditions.
<b>The unit stops working.</b>	Remove and insert the batteries again.
<b>All settings are canceled.</b>	If the batteries are depleted, removed, or the unit is subjected to strong shock, all settings are canceled, and the volume is reset to 10.

# Caution

## ■ Batteries

- Do not peel off the covering on batteries and do not use if the covering has been peeled off.



### Pause

- You cannot use [ ] to skip to any previous tracks during random and random repeat play modes (→ page 6).

### Search

(backward) (forward) While playing, press and hold.

- You can only search within the current track except for during all track repeat (→ page 6) and regular play.

### Album skip

(backward) (forward) Until the album you want appears, press and hold.





## Changing the play mode

**PLAY MODE** Each time you press



**(MP3)** You cannot select "RND" and "A B" with MP3.

### ■ Specifying the AB segment

- MEMO** Press to specify the start point (A).
- Press once more to specify the end point (B).
- Stop or skip (⇒ page 5) to cancel.
  - If you do not specify point B this will automatically be set as the end of the disc. Repeat begins when this point is reached. You can also specify point B again by pressing [MEMO].

## Changing the sound quality

**EQ** Each time you press




- The effect may differ with different kinds of music.
- Depending on the recording conditions, sound may be interrupted when switching between EQ settings.

## Changing the anti-skip mode (CD-DA)

The anti-skip function (ANTI-SKIP SYSTEM) reduces or eliminates skipping caused by vibration. You can change the anti-skip memory time.

**MEMO** While stopped, each time you press and hold



**(MP3)** You cannot change the memory time for MP3. It is a maximum of 100 seconds for MP3 recorded at 128 kbps.

## Enjoying more natural sound (Digital Re-master) (MP3)


You can regenerate signal frequency lost during compression, restoring the sound to near pre-compression form.

**MEMO** While stopped, each time you press and hold
