GENERAL DESCRIPTION

The HI 93748 meter measures the manganese content in water and wastewater in the 0 to 300 $\mu q/L$ (ppb) range.


The meter uses an exclusive positive-locking system to ensure that the cuvet is in the same place every time it is placed into the measurement cell.

The reagents are in liquid and powder form and are supplied in bottles and in packets. The amount of reagent is precisely dosed to ensure maximum repeatability.

Display codes aid the user in routine operations.

The meters have an auto-shut off feature that will turn the instrument off after 10 minutes of non-use.





A zero reading was not taken. Insert a 2680 sample before addina reagent and press 7FRO.





Under range. A blinking "0.00" indicates the zero reference. Check the procedure and make sure you use the same cuvet for reference (zero) and measurement.

> Over range. A flashing value higher than the maximum concentration readable (see specifications) indicates that the sample absorbs too much light, meaning that the concentration is too high. Dilute the sample.



Light over range. The cuvet is not inserted correctly and an excess ambient light is reaching the detector. If the cover is properly installed, then contact your dealer or the nearest Hanna Customer Service Center



MEASUREMENT PROCEDURE

• Turn the meter on by pressing ON/OFF.

Note: for best results perform your tests between 20-24 C.

- When the LCD displays "- -", it is readv.
- · Fill one cuvet up to 1.5 cm $(\frac{3}{4})$ below the rim with 10 ml of deionized water.
- Fill a second cuvet up to 1.5 cm (34")below the rim with 10 mL of sample.
- · Add the content of one packet of HI 93748A ascorbic acid to each cuvet, replace the caps and shake gently.

Add 0.2 mL of the HL 93748B alkaline-cvanide reagent solution to each cuvet, replace the caps and shake gently.


- · Add 1 mL of the HI 93748C 0.1% PAN indicator solution to each cuvet, replace the caps and shake gently.
- · Place the cuvet with the reacted deionized water (blank) into the holder and ensure that the notch on the cap is positioned securely into the groove.

Press READ TIMED and the display will show the countdown prior to zeroing the blank. Alternatively wait for 2 minutes and press ZERO. In both cases "SIP" will appear during zeroing.

Press READ DIRECT. "SIP" will appear during measure-



- The instrument directly displays concentration in ua/L of manaanese on the display.
- Note: a temperature above 30 C may cause turbidity. In this case, before zeroing and taking readings, add 2-3 drops of Dispersing Agent (HI93703-51) to each cuvet and swirl until complete dissolution of the turbidity.

INTERFERENCES

Interference may be caused by: Aluminum above 20 ma/L Cadmium above 10 mg/L Calcium above 200 mg/L as CaCO Cobalt above 20 ma/L Copper above 50 mg/L Iron above 10 mg/LLead above 0.5 ma/L Magnesium above 100 mg/L as CaCO₂ Nickel above 40 ma/L Zinc above 15 ma/L.

TIPS FOR AN ACCURATE MEASUREMENT

The instruction listed below should be carefully followed during testing to ensure best accuracy.

- Do not touch the cuvet walls with hands.
- · In order to maintain the same conditions during the zeroing and the measuring phases, it is necessary to close the cuvet to prevent any contamination.
- · Do not let the test sample stand too lona after reagent is added or accuracy will be lost.
- · Whenever the cuvet is placed into the measurement cell, it must be completely free of fingerprints, oil or dirt. Wipe it thoroughly with HI 731318 or a lint-free cloth prior to insertion.
- · It is important that the sample does not contain any debris. This would corrupt the readings.
- It is possible to take multiple readings in a row, but it is recommended that a zero readina be taken for each sample and that the same cuvet is used for zeroina and measurement
- · It is important to discard the sample immediately after the reading is taken because the glass might become permanently stained.
- Shaking the cuvet can generate bubbles in the sample, causing higher readings. To obtain accurate measurements, remove such bubbles by swirling or by gently tapping the vial.
- · All the reaction times reported in this manual are referred to 20 C (68 F). As a general rule of thumb, they should be doubled at 10 C (50 F) and halved at 30 C(86 F).

BATTERY REPLACEMENT

Battery replacement must only take place in a non-hazardous area using a 9V alkaline battery.

Simply slide off the battery cover on the back of the meter. Detach the battery from the terminals and attach a fresh 9V battery while paying attention to the correct polarity. Replace the battery and the cover.
