

A= Assembly LocationWL= Wafer LotYY= YearWW= Work Week






Figure 1. 28–Lead Pinout

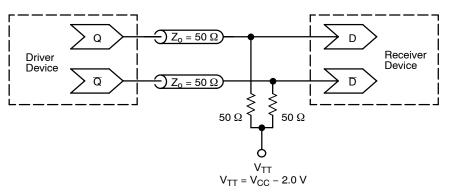


Figure 3. Typical Termination for Output Driver and Device Evaluation (See Application Note AND8020/D – Termination of ECL Logic Devices.)


