

Troubleshooting guide

Before requesting service, make the following checks. If you are in doubt about some of the check points, or if the remedies indicated in the chart do not solve the problem, see "Product information" on page 3 for assistance.

<p>No play.</p>	<ul style="list-style-type: none"> ● The HOLD function is on. Release HOLD. (⇄page 5) ● The batteries may have run empty (⇄page 4). (If play is extremely short even after fully recharging the batteries, the batteries may have exceeded their life. Rechargeable batteries can be recharged approximately 300 times.) ● The disc isn't correctly set. ● The disc is scratched or dirty. (Tracks skipped.) ● There is moisture on the lens. Wait for about an hour and then try again. ● The lens is dirty: clean it with a blower (recommended product: SZZP1038C). If the lens gets marked with fingerprints, gently wipe them off with a cotton swab. ● The unit may not read MP3 correctly if it is shaken while it is reading the files. ● Play of a multi-session disc may not be possible if there is a blank data segment between sessions. ● If there is large JPEG data etc. within a MP3 file, sound may become muted and play may not be possible. ● If you try playing a CD that contains CD-ROM format data and normal audio data (CD-DA), output from one of the above may become silent, and play may not be possible.
<p>No sound or there is a lot of noise.</p>	<ul style="list-style-type: none"> ● Ensure the plugs are inserted firmly. ● Wipe the plugs clean with a clean cloth. ● Noise may occur when playing MP3 if recording quality is poor. ● The elapsed playing time disappears and sound is interrupted if bumps continue repeatedly. ● When listening with the speaker, sound cannot be heard from the earphones. ● SL-J905 When you are listening with the earphones and try to connect with the speaker, the unit automatically shuts down in order to prevent noise.
<p>Cannot hear sound from the speaker.</p>	<ul style="list-style-type: none"> ● SL-J905 Turn [SPEAKER, OFF ON] to [ON] (⇄page 5). ● SL-J910 Are you using the AC adaptor?(Cannot play by just inserting rechargeable batteries.)
<p>Play doesn't resume from the last point stopped.</p>	<ul style="list-style-type: none"> ● This doesn't work if you change discs. ● This doesn't work during random play. ● It may not work correctly under some conditions.

<p>Play doesn't start from the first track.</p>	<ul style="list-style-type: none"> ● Random play modes may be on (⇄page 6). ● Play resumes from the last point stopped.
<p>Cannot search through tracks.</p>	<ul style="list-style-type: none"> ● You cannot search through MP3 files.
<p>Cannot specify the AB segment.</p>	<ul style="list-style-type: none"> ● You may not be able to specify segment A or B at the end of disc.
<p>Cannot change the Digital Re-master mode.</p>	<ul style="list-style-type: none"> ● If [◀◀] or [▶▶] is pressed before [MEMO/ DISP] you cannot change the Digital Re-master mode.
<p>Digital Re-master does not work.</p>	<ul style="list-style-type: none"> ● Depending on the type of MP3 disc recording, the effect may not appear.
<p>Cannot skip albums.</p>	<ul style="list-style-type: none"> ● You cannot skip between the first and last albums during play.
<p>Cannot hear the remote control's operation tone.</p>	<ul style="list-style-type: none"> ● The operation tone may be off (⇄page 6). ● You cannot hear this sound when listening with the speaker.

Play time should be restored after a few recharges. ● The batteries can go flat if you leave the AC adaptor connected after recharging is complete.
<p>The battery indicator fails to appear or is incorrect.</p>	<ul style="list-style-type: none"> ● The indicator does not appear when the AC adaptor is connected. ● The indicator does not appear correctly under some conditions.
<p>The unit stops working.</p>	<ul style="list-style-type: none"> ● Disconnect then reconnect all power sources (batteries and AC adaptor).

CDs

- Do not use irregularly shaped CDs.

Listening



Do not play your headphones or earphones at a high volume. Hearing experts advise against continuous extended play.

If you experience a ringing in your ears, reduce volume or discontinue use.

Do not use while operating a motorized vehicle. It may create a traffic hazard and is illegal in many areas.

You should use extreme caution or temporarily discontinue use in potentially hazardous situations.

Even if your headphones or earphones are the open-air type designed to let you hear outside sounds, don't turn up the volume so high that you can't hear what's around you.

Sound can be deceiving. Over time your hearing "comfort level" adapts to higher volumes of sound. So what sounds "normal" can actually be loud and harmful to your hearing.

Guard against this by setting your equipment at a safe level BEFORE your hearing adapts.

Listening from the speaker

You can listen using the speaker or the earphones. However, you cannot do both.

Playing MP3

This unit can play MP3 files you have recorded to discs. MPEG Layer-3 audio decoding technology licensed from Fraunhofer IIS and Thomson multimedia.

HOLD

This function causes the unit to ignore accidental button presses. Set to HOLD so the unit doesn't power on accidentally or play is interrupted.

- The unit and remote control each have independent HOLD switches.

Note on CD-R and CD-RW

This unit can play CD-R and CD-RW recorded with CD-DA or MP3. Use an audio recording disc for CD-DA and finalize* it when you finish recording. The unit may not be able to play some discs due to the condition of the recording. *A process performed after recording that enables CD-R/CD-RW players to play audio CD-R and CD-RW.

Resume function

Play begins from the last point stopped. Replacing the disc cancels the function.

Auto off function


If the unit is left in stop mode for approximately 10 minutes, the unit turns itself off automatically.

The display light

The light in the remote control's display comes on for about 5 seconds when you press a button, unless the hold function is on.


Connecting the speakers

Anti-Skip System

This system reduces the skipping caused by vibration to a minimum. You can change the anti-skip memory time for CD-DA to improve sound quality. While stopped, each time you press and hold [•MEMO/•DISP]



- You cannot change the memory time for MP3. It is a maximum of 100 seconds for MP3 recorded at 128 kbps.
- SL-J910 You cannot change when connected to the speaker.

Other remote control functions

Turning the operation tone off

Press and hold [EQ] until "BP OFF" appears. ("BP ON", tone on)

Adjusting the contrast of the display






MP3

This unit can play MP3, a method of compressing audio without overtly hurting audio quality.

When creating MP3 files to play on this unit

Disc formats: ISO9660 level 1 and level 2 (except for extended formats)



Limitations on MP3

- Only artist name and track name ID3 tags (version 1.0 and 1.1) are displayed.
- This unit is compatible with multi-session but if there are a lot of sessions it takes more time for play to start. Keep the number of sessions to a minimum to avoid this.
- This unit cannot play files recorded using packet write.
- If a CD-ROM format CD contains MP3 and files other than MP3, only the MP3 files will be playable.
- Depending on how you create MP3 files, they may not play in the order you numbered them or may not play at all.
