
The device is designed for low-voltage (3.3 V) VCC applications, but it could be used to interface to 5-V supply environment for inputs

All inputs are equipped with protection circuits against static discharge.

- Available in JEDEC SOP, JEITA SOP, TSSOP and VSSOP (US)
- Power-down protection is provided on all inputs and outputs
- Pin and function compatible with the 74 series (74AC/VHC/HC/F/ALS/LS etc.) 32 type





AC Waveform





